POLAND BOARD OF SELECTMEN MINUTES OF MEETING August 21, 2012



CALL TO ORDER/PLEDGE OF ALLEGIANCE

Chairman Wendy Sanborn called the meeting to order at 7:00PM with Selectmen, Larry Moreau, Lester Stevens, Steve Robinson and Jim Fernald present. The Town Manager and Assistant Town Manager were also present.

EXECUTIVE SESSION - Personnel Matter

Selectman Stevens moved that the Board of Selectmen enter into executive session with Rosemary Kulow pursuant to Title 1 MRSA Chapter 13 Public Records and Proceedings, subsection 405 Executive Sessions, subsection 6(A) to discuss a personnel matter. Selectman Moreau seconded the motion. Discussion: None.

Selectman Stevens moved that the Board of Selectmen enter into executive session with John Cleveland and Rosemary Kulow pursuant to Title 1 MRSA Chapter 13 Public Records and Proceedings, § 405 Executive Sessions, § 6 (C) to discuss the consideration of property use or acquisition. RECOGNITION OF VISITORS (A list of visitors who attended the meeting are attached to these minutes.) Don Stover spoke to the Board regarding the dam located near the Fire Rescue Station and the positive resource it is for the town. He felt that with a few changes it could continue to be used by individuals. Selectman Moreau recommended directing the Conservation Commission to create a plan for the dam's use to develop a safe and pleasant area for people. In addition, Selectman Moreau recommended that the Board authorize the commission to get an opinion through the Maine Municipal Association regarding the project. The remaining members of the Board were in agreement with Selectman Moreau.

REPORTS AND COMMUNICATIONS

Town Manager's Report – In addition to a written report, the manager provided a verbal summary of activities that took place subsequent to submitting her report.

- DEP Violations DEP will be looking at the worst violations and developing a training session for the Planning Board; the violation letter should arrive next week; the CEO will be able to act on those violators that deliberately went against orders.
- Received prices from AVCOG on cutting edges
- Obtaining prices for municipal paving needed due to water line.

Department Head Reports - Public Works/Lewiston Junction Road Paving - the Board instructed the Public Works Director and Road Commissioner to contact the Auburn Water & Sewer District and have the manholes raised this year (1") as opposed to paving over them and having to dig them up next year. The Board's objective is that the Lewiston Junction Road needs to be completed this year with all maintenance.

NEW BUSINESS

Citizen Request for Building Permit Refund - Selectman Moreau moved to authorize a permit refund to Peter Craig based on building permit #BP2012-045 in the amount of \$1,253.60. Discussion: CEO Adams explained that permits are good forever; however the project must start within the first 6 months. If work stops for more than 6 months the permit is void. This rule is contained in the recent adoption of the MUBEC building codes. The Board would like to have the section of the code that speaks to this sent to them. CEO Adams further noted that there is no longer an application fee. Selectman Robinson seconded the motion. Discussion: None.

<u>CEO/Planner - Request for New Zoning Maps</u> - Selectman Moreau moved to approve CEO Adams' request for new Zoning Maps. Selectman Robinson seconded the motion. Discussion: The CEO explained the need for the new maps is to update the location and dividing of lots as this has not been updated for some time. He stated that the data from O'Donnell & Associates has already been sent over to AVCOG. The cost will be \$500 which will be paid for from the town contingency account. Vote: 5-yes 0-no

<u>Historical Society/Temporary Sign Permit</u> - Selectman Moreau moved to grant the Poland Historical Society permission to erect the fund raising thermometer under section 508.18.G of the town's Comprehensive Land Use Code entitled "Signs Allowed in all Districts without a Permit from the Code Enforcement Officer".
