Establishment of New Town Committee - Selectman Moreau moved to establish a committee whose charge shall be to study alternative uses with any associated costs for the McConaghy property. Selectman Robinson seconded the motion. Discussion: The committee shall have 9 members from the following areas: Budget Committee - 1, Selectmen - 1, Planning Board - 1, Community &

Economic Development Committee - 2; Ricker Trustees - 2, Historical Society - 1, Residents at Large -1, and 3 Town Department Liaisons. The committee shall not negotiate the purchase of the house with the owner. The public is welcome to attend all meetings. The committee does not preclude what the Board has to do with the property. The completion date charged to the committee date shall December 31, 2012
