Actions were taken on applications submitted for the following locations:

Application to renovate existing vestibule and install an ATM at

#### 500 Westchester Avenue

After a brief discussion, a motion to approve was made by Mr. Hoge and seconded by Mr. Fragiacomo. A vote was taken and the motion was unanimously approved.

Application for changing signage to reflect Wells Fargo's logo at the following location:

#### 133 North Main Street

After a brief discussion, the request was approved with the condition that the signs be made smaller, i.e. front sign should not exceed 25 sq ft. letters should be the same size as existing ones. There was no problem with the sign on top of the building, however, the one by the parking lot should be smaller – 14' off the ground and not to exceed 25 sq. ft. A motion to approve the permit with the necessary changes was made by Ms. Cronca and seconded by Mr. Fragiacomo. A vote was taken and the motion unanimously approved.
