## **421 Boston Post Road**

The Board reviewed plans to renovate interior spaces to create a health club setting with locker rooms, group fitness studios and work out space.

The applicant proposed to replace the windows, install repointed brick and paint the cinder block wall. The signage and awnings will be proposed at a later date.

## 43 N. Main Street

The Board reviewed plans for three signs.

Present on behalf of the application was Jeff Trell, the applicant.

The applicant stated that there is a change in ownership and they are not replacing the storefront. They will be renovating the inside and painting bricks. They need to speak with the Building Inspector regarding painting over the brick. The Berger True Value sign has 18" push through letters, and the awning reduced the projection and drops down.

A motion to approve was made by Chairman, seconded by Ms. Concra, and unanimously approved, upon the condition is stamped by an engineer or architect. Also, these signs are approved on the condition that the back sign is changed to 18 inches and an awning with reduced projection and drop down.

#### 359 Willett Avenue

The Board reviewed plans for one sign for the "Pork Store."

Present on behalf of the application was Jacek Michno, the applicant.

The applicant stated he has owned The Pork Store for twenty-four years. The renter changed the sign after the old sign rusted. The sign has been up for eighteen years.

A motion to approve was made by Ms. Concra, seconded by Chairman Hume, and unanimously approved, **upon the condition that the sign elevation is stamped by an engineer or architect.**
