Dear Mayor Pagano,

Pursuant to Section 41.34 of Mental Hygiene Law of the State of New York, this letter shall serve as formal notification of Ability Beyond Disability's intent to establish a community residential home to be located on property we own on Betsy Brown Road, adjacent to 51 Betsy Brown Road. This will be a home for six (6) adults with developmental disabilities, licensed under the Office for People with Developmental Disabilities (OPWDD).

Ability Beyond is a not-for-profit agency with business offices at 4 Berkshire Boulevard, Bethel, CT and 120 Kisco Avenue, Mt. Kisco, NY. We have a 60 plus year history of providing community services for people with disabilities and look forward to working with you and other Village officials in creating this home.

You may recall that we had initiated this process earlier and withdrew it as we sorted through other issues we became aware of regarding the property on which we plan to build the home. We are now prepared to proceed with addressing sub-division and site plan/development as well as this step pursuant to Section 41.34 of Mental Hygiene Law.

We have been advised by OPWDD that the area surrounding our property is not "saturated" with facilities of this nature and that they support our efforts to develop the planned home. We would be pleased to provide you with a printout of a directory listing similar facilities in the area. Under Section 41.34, the Village may 1) Support the site proposed, 2) Offer another suitable site(s) that could accommodate the home or 3) Object because the concentration of facilities of this nature would substantially alter the nature and character of the area. If the Village does not respond within forty (40) days, Ability Beyond may proceed with establishing the home.

It is our intent to immediately begin working with Village officials to secure necessary approvals and, again, we look forward to working with you and your Village colleagues throughout the process.

Firstly, thanks Michael, for providing your timely input (below). I am asking that your email be included in the record for Ability Beyond Disability's application.

I write to let you all know that I have requested that this meeting be relocated and re-noticed to be held IN THE SENIOR CENTER at 222 Grace Church St TOMORROW at 6pm.

The public hearing for this matter, and the public meetings scheduled for this week were already set up before I took office, and there is not otherwise sufficient time allowed by statute to extend this particular item until next week.

Anticipating a large crowd tomorrow, however, I have asked that we move tomorrow's meeting from the smaller 1st floor conference room into the larger Senior Center located IN THE REAR OF THE PARKING LOT.

We will amply place signage at the original meeting location to direct people to the Senior Center that is located at the back of the parking lot.

I will separately address your request for feedback - but I wanted to make sure that you and your neighbors had as timely a notice as possible about the room change tomorrow.

Thanks again for taking the time to provide your input. I appreciate receiving your's and your neighbors' input, and I will certainly and appropriately weigh it in my personal decision process and deliberations.

I have also copied the entire Board of Trustees and village management staff so they also receive your input and the meeting location change.

Dennis and Dan, forwarding you the following for your thoughts and suggestions on this matter. If possible, please circulate to the other trustees. We had

included you on the food chain of emails last time and forgot to do so this time. As the two of you are aware, the possible adding of a group home on Betsy Brown by the school is concerning to many of us. In the last 24 hours, many of us learned that this issue has resurrected itself yet again. We are glad the board of trustees elected to table this until Thursday, since many of us would have found out that this closed issue was suddenly opened and voted on. In the past, this issue was a concern in our area due to the following: safety, zoning, drainage/flooding, proximity to school for safety and transient workers, etc. The issues on this matter are very long. Those issues are still the same issues today. The targeted location on Betsy Brown Road is by far the most dangerous part on Betsy Brown Road, due to a three way intersection, blind spots and a major speed trap. We in the community for years have been requesting speed bumps in the area due to safety (speeder problems), safety reviews, traffic studies, since speeding is excessive. We have also voice concerned about speeding buses on that location, which is well documented at the school district. The problem is this old issue keeps coming back, and none of us are sure what to do with it.

In very recent years, this section of Betsy Brown Road near King Street has also become an overflow parking lot for King Street school pickups due to the heavy shortage of parking. Creating more traffic in this area with workers and family members going in and out is only going to accelerate these safety issues in this section of Betsy Brown Road. Many of us are challenged to attend tomorrow night's meeting due to extremely short notice so we are looking for your comments on this matter. As a parent, I lose sleep at night thinking that we would put in facilities near a school that have transient workforces (high turnover and limited screened employees) near a school, which is the type of workforce that is typically seen in this work environment. Unfortunately, there are not a lot of positives about this.

Please note that none of us are against disabled individuals, the core of the matter is about safety and the other issues summarized above. Many communities provide zero support (have no group homes, no school programs for disables, etc), yet we have close to 15-18 group homes (still unable to get an accurate number). Clearly, Port Chester is doing more than its fair share and we have more in our community than many others. Many Westchester towns have none and they have more budget dollars to do things for their schools. The zoning and flooding concerns are also a problem and we have still not been able to see a study on this. In past meetings from a few years ago, we talked about having studies authorized for traffic, zoning, drainage/flooding but understand studies got tabled since no longer needed for this project.

The last but not least comment, which I am informed that I can't bring up is the tax aspect of this, since the government approved this. Unfortunately that is not an acceptable response for many of us. Our school district is a distant last on the amount of taxable revenue available per student in Westchester, Putnam, Dutchess and Rockland County. This stat is a fact, since the report is published every year around school budget time. We have less dollars to work with than any other school district in the four counties. As a resident of Port Chester for 19 years, it is frustrating to watch our district fall further behind than any other school in this area. We have been dead last for more than 10 years and we are

falling further each year compared to the next lowest school district (out of 150+ districts schools) in our surrounding counties including Westchester. A primary reason for this is that we as a community permit too many organizations into our community and giving them a free pass on taxes. I understand the need to have some of these organizations (e.g., religious organizations, etc.) but we have hit an extreme in Port Chester. If you can't put a stop on this for any or all of the above (safety, etc.), then consider a moratorium on any new requests, including the Betsy Brown one, for any new projects in the short term involving properties coming off the tax rolls from a fiscal responsibility point of view.

Any suggestions or thoughts that you can provide us would be much appreciated. Unfortunately I will most likely not be in attendance tomorrow night due to a conflict that can't move at very last minute. Learned too last minute of this trustee meeting. Hopefully the above will be helpful for the board of trustees in their decision process. I suspect that many parents will be showing up even if short notice to reiterate the above. Personally, I am still a little shell shocked that this issue continued to keep coming back. Again, any guidance that you have for the group is much appreciated. Thank you for any help that you can provide on this matter. Best wishes.
