SUSPENDING PARKING REGULATIONS ON OVERNIGHT PARKING ON LOCUST STREET, ORCHARD STREET AND HIGHLAND STREET

Chester, New York:

WHEREAS, the Board of Trustees received correspondence dated April 6, 2015 from Nardo Associates, Managing Agent for the Landmark Condominium Association, seeking the Village's assistance with regard to work that must be done to the parking garage; and

WHEREAS, the proposed work will necessarily result in the displacement of many vehicles onto the surrounding streets; and

WHEREAS, the Board desires to mitigate the impact of this action; and

WHEREAS, the Traffic Commission has recommended rescinding the overnight parking regulations on Locust Avenue, Orchard Street and Highland Street for a fifteen-day time period to commence once proper permits are issued; and

WHEREAS, the Building Inspector has advised that he requires an application for a renewal of the permit to be accompanied by a report from an engineer as to the structural integrity of the garage. Now, therefore, be it

RESOLVED, that the Board hereby suspends the application of the Code of the Village of Port Chester, Schedule XIV, Section 319-75 pursuant to the provisions of Section 319-21A, "Nightime Parking Prohibited Certain Hours", upon the following streets for a fifteen-day period to commence following the issuance of a renewed permit from the Building Department:
