On motion of TRUSTEE CECCARELLI, seconded by TRUSTEE ADAMS, the public hearing was declared open.

Legal Intern David Kenny described the changes and additions included in this local law.

PUBLIC COMMENTS:

Angelo Williams of Avalon Towing commented that he and others have filed a law suit because this law hinders them from making a living. You cannot tell private property owners how to protect their property.

Mark Clancey of 24-Hour Towing commented there does need to be known who is doing the booting and towing. On private property a police officer cannot write a ticket.

Goldie Solomon commented that booting is threatening. We can only do this legally through the police department.

Mr. Anthony Tirone, on behalf of the Capitol Theater, commented this issue is needed in the Village. The predatory way that booting and towing in lots has had an effect on the economy as well as restaurants and the Capitol Theater. A legitimate law is definitely needed. Now, property owners have no responsibility. The towing company cannot take all the responsibility. If a car is towed to Stamford, the Village police department has no jurisdiction.

Mr. Mark Clancy commented he has an insurance policy that enables him to operate on private property. He refuses to release a vehicle to someone who may be under the influence.

Mr. Howie Ravikoff commented that his family includes several properties, including parking lots. We own lots which are residential. The cost will affect us as well. Orange stickers that I place on cars deem to deter people from parking illegally again. We should be able to take care of ourselves.

Mr. Richard Abel commented on abandoned vehicles on private property. Can you not call a tow truck because you do not have a contract? Every property housing three families and up would have to post it to remove an abandoned car. A two foot by two foot sign is required with the proposed law.

Mr. Steve Shenartz commented that the tow truck operators are being punished by changing their fees and changing the signs. You can't make tow truck operators accept credit cards. This should be an option. The 24 x 24 signs are larger than the no parking signs in Port Chester. People are booted and towed because they do not obey the rules. Stickers should not be $8-1/2 \times 11$. The property owners should not be responsible. We call in to the police department every time we make a boot; why is a monthly log needed to take to the police?

Village Attorney Cerreto commented he would like to provide background from the police chief.

Police Chief Conway commented we have an industry which, to some degree, exercises control over people. Port Chester, by virtue of our population density, have a difficult time providing enough parking. We have to look into the background of operators because they are immobilizing or removing personal property.

Village Attorney Cerreto commented we have worked long and hard to provide a law for the protection of the health, safety and welfare of our residents. David Kenny commented this provides private property owners with methods to police their private property and to exercise their private property rights.

Trustee Ceccarelli commented that best practices have been exercised and much research has gone into this. Municipalities have these laws in effect. The staff did a good job putting this law together.

Trustee Brakewood commented he agrees with the police chief's assessment. When someone comes from out of town and a lot is almost empty; if they park there they will be towed or booted. The downtown as lost business because of the booting and towing in privately owned lots. This law is a reaction to a very vibrant booting and towing industry in this Village. He would like the Chamber of Commerce coordinate parking for the various downtown businesses. The 10-mile towing is too far. The car should remain in Port Chester.

Village Manager Steers commented that Walgreen's is public parking. There should not be towing or booting at that location.

Mayor Pilla commented on the booter's insurance. Using credit cards is a right. We can implement this law and in six months we can review the law.

Chief Conway commented that quarterly instead of monthly logs would be ok but that monthly is preferred. They just need to be able to go back and check data. They also have cruelty to animals laws for animals left too long in a car.

On motion of TRUSTEE BRAKEWOOD, seconded by TRUSTEE CECCARELLI, the public hearing was closed.

Mayor Pilla commented on his service to the Village. He wants to leave a legacy of being open an honest.

PUBLIC COMMENTS AFTER THE PUBLIC HEARING:

Ms. Goldie Solomon commented on the school tax. We don't need any more residential properties. Our schools are overloaded. Halloween in the Park will be Wednesday, October 28th at Lyon Park.

Ms. Bea Conneta commented on Mayor Pilla and the ethics question. The Village staff is great.

Mr. Richard Abel commented on the pilots on the Starwood Project. The Board can set the pilots or limit the pilots.

Mr. Joseph Rende commented on the passing of Paul Costa. He would like to add Paul Costa Way below Prospect Street on the street signs. Regarding the Rye Town debate, there was a mention of Exemption Terminations – how does that affect the Village and other taxing jurisdictions? Regarding the cartoon in the newspaper, he and Mr. Terenzi were the only two people who raised the issue. It goes to the benefit of LaBerge that Mayor Pilla spoke at their conference.

Mr. Michael Halpin of Build Up New York, advocating for men and women for good jobs. In Starwood's proposal there is no offer for jobs. We should have a binding agreement which gives Port Chester the jobs it deserves.

Mr. Frank Ferrera commented as commissioner for the I.D.A. The I.D.A. has public hearings before they take any action. In the interest of continued transparency, and misunderstandings about the I.D.A., we have posted our comments on the Village website.

Village Manager Steers commented about his rights and abilities to do his job without coercion, interference or threats; and to be able to inform the Board of issues of concern without fear of retaliation.

Mr. Tartaglia commented on the Coney's Parcel of downtown. We submitted an application to the Board back in 2008 to change the zoning from Commercial to Mixed Use. We are getting close to a conclusion. We would have retail on the first level and four levels of rental market rate apartments above. We have had numerous meetings and went to the Planning Commission. We have created a bonus density like the residential project. We have amended our petition. We have reduced the plan from five stories to four stories.







Launching Ramp Rules

- All boats to be launched or hauled from the water must be in the time period of 2 Hr. before and 2 Hr. after high tide.
- 2. A valid boat registration must be shown before launching any boat.
- Port Chester residents are permitted to launch in the Spring and haul in the Fall with no charges. (NO DALLY OR WEEKLY LAUNCHING) all trailers and vehicles must leave club property after launching or hauling.
- Boats being moored at the Village Marina are afforded the same launching and hauling Privileges as village residents.
- Due to safety reasons there no launching or hauling of Personal Water Craft (Ski-Doo's, Wet Bikes, Jet Ski's) allowed.
- Exceptions to the above rules may be made in an emergency situation or if a boat must be hauled for repairs.
- The Port Chester Yacht Club reserves the right to refuse anyone launch privileges at the club if the equipment they are using appears to be unsafe inadequate to support the boat being launched.
- a. The Port Chester Yacht Club assumes no responsibility for any damages incurred to boat, trailer, or vehicle while using launching ramp. 11/2008

- All boats to be launched or hauled from the water must be in the time period of 2 hours before and 2 hours after high tide.
- 2. A valid boat registration must be shown before launching any boat.
- Post Chaster residents are permitted to launch in the Spring and hash in the Fall with no charges. (NO DAILY OR WEEKLY LAUNCHING) all mallers and vehicles must leave club property after launching or busiling.



RETAINING SPECIAL COUNSEL WITH REGARD TO 2016 VILLAGE ELECTION

WHEREAS, the United States government filed an action in the United State District Court for the Southern District of New York pursuant to Section 2 of the Voting Rights Act of 1965, as amended, 42 U.S.C. Section 1973 on December 15, 2006; and WHEREAS, the Court granted the motion of plaintiff-intervenor Cesar Ruiz to intervene on April 6, 2007; and

WHEREAS, by Decision and Order dated January 17, 2008, the Court found that the Village's at-large method of electing Trustees violates Section 2 of the Voting Rights Act and prevents Hispanic voters from participating equally in the electoral process; and

WHEREAS, by order dated November 6, 2009, the Court ordered the Village to implement cumulative voting, its proposed remedy to the violation, as an election scheme to remedy the Section 2 violation; and

WHEREAS, on February 25, 2010, the Court signed a Consent Decree with regard to this matter, which included a requirement that the Village implement a Voter Education Program, covering the 2010, 2013 and 2016 Village Elections; and

WHEREAS, the parties executed addenda to the Consent Decree to provide for the operational aspects for each individual election; and

WHEREAS, as in the 2013 Village Election, the Village Attorney has recommended that the Board authorize retaining the law firm of Sokoloff Stern, LLP. Carle Place, New York with regard to the 2016 Election; and

WHEREAS, this firm primarily represents municipalities and school districts in the litigation, trial and appeal of cases predominantly in many areas, including election law and served in the same capacity for the Village in the 2013 Village Election; and

WHEREAS, funds have been appropriated in the FY 2015-2016 Village Budget for this expense. Now, therefore, be it

RESOLVED, that the law firm of Sokoloff Stern, LLP, Carle Place, New York be and is hereby retained to act as Counsel of Record in the matter of United States of America and Cesar Ruiz v. Village of Port Chester (06 Civ. 15173) with regard to the 2016 Village Election, as set forth in the annexed proposal, compensation to be capped at \$7,500 unless otherwise authorized by the Board.

VILLAGE MANAGER'S REPORT

Village Manager Steers gave an update on the budget document that was distributed. The financial report looks different from last year because it contains updates on priorities and strategies and on our fiscal trends. We should do a six-month review at the end of November.

The Village Emergency Plan essentially sets the framework for us to do some emergency planning we have not yet done. It identifies the requirements and gaps; and the threats and hazards. We need to focus in on our responsibilities for public safety. By January we should have the comprehensive plan completed.

DISCUSSIONS

- 1. Commercial assessments
- 2. Tax cap rebates:

Trustee Terenzi commented we have had discussions with the Supervisor about assessments and how things are done. We have to explore other boards, for instance upstate one Board serves as the assessor. We should have a consultant come in and do a test on the top valued properties in the community. The brunt of it is the commercial. If they are undervalued, how does that affect the tax cap? Why should we be hampered with the tax cap if we are going to be generating enough assessable. There have to be communities growing faster than the tax cap – how do they handle it?

3. Building permit amnesty program:

Mayor Pilla commented that the amnesty program has expired. The question is do we want to renew it as it is today and that would provide people a chance to get into amnesty. Trustee Terenzi commented that after the election in March so we should extend it until June to give the new Board time some time. Trustee Ceccarelli said an extension will not move people to bring their property up to code. The Village has already absorbed over a million dollars in what could have been collected fines.

The second part of Amnesty is that many people did not know the status of their house before they bought it. Maybe we want to bundle the old open permits on the house before the present owner. Trustee Ceccarelli commented we should weigh in on this, especially the two year period. The code enforcer should make a determination on how soon work needs to be done.

Mayor Pilla commented we should extend this program to June 30, 2016. A resolution will be set forth.
