This is a drainage area for the parking lot. Trustee Brakewood asked the cost per square foot. The concrete work was \$10/sq. ft. The simulated brick is \$14.

Adoption of Local Law No. 6 of 2014

AN INTERIM LOCAL LAW FURTHER MODIFYING THE AMNESTY PERIOD OF THE PERMIT AMNESTY PROGRAM

SECTION 1: Purpose and Intent.

Pursuant to Local Law No. 4 of 2012, the prior Board of Trustees adopted an interim local law establishing a permit amnesty program to all properties within the Village of Port Chester under certain terms and conditions. The local law provided for a time period to make application for such amnesty which period has been extended with the last extension being to September 30, 2014. SECTION 2: Amnesty Period

Section 2 of Local Law No. 4 of 2012 is further modified so that the amnesty period for the Permit Amnesty Program shall be deemed to expire on September 30, 2015.

SECTION 3: Effective Date

This local law shall be effective upon due publication and filing with the Secretary of State.

PUBLIC COMMENTS

Deputy Mayor Gene Ceccarelli asked if there was anyone from the audience who would like to make any public comments.

Comments were made by:

Ms. Goldie Solomon commented on the Columbus Day Parade. This is very good. It is Italian but it should also be Spanish because if Isabella did not give him the money, Columbus never would have gotten here. The Grand Marshall of the parade is Bob Vitti, who is the Port Chester High School band director. We are a diverse community. The sewer rental tax is a horror story. If we have to pay this we should pay in Port Chester and not have to send this money to New Rochelle. We are a low to middle income

community and we have more off the tax rolls than any other village our size. We have to get our taxes down.

Mr. Giangrande commented on what is going to happen if someone has a bad sidewalk and doesn't do anything about it. Trustee Terenzi commented that on the agenda they are going to talk about the sidewalk betterment program. Mr. Giangrande commented on hedges being eight to ten feet. They should be no taller than four feet.

Mr. Tom Ceruzzi commented on the DPW on the beautiful job at the Vietnam Memorial. He commented on parking in the C4 and C5 districts. With so many people coming in where are they going to park. Trustee Terenzi commented we opened up Marvin Place but people don't want to park there. Mr. Ceruzzi commented on the colors of some of the retail buildings and the clutter in the windows.

Ms. Beatrice Conetta commented on how the surrounding communities benefit by our box stores and our restaurants. She commented that Port Chester was on the list of the highest tax communities in Westchester County. The bulkhead has not been addressed and the MTA is getting away with murder. The roads need to be repaved. The stolen money from the meters and police department has never been resolved. The developers have had a field day in Port Chester. The Board may have inherited the problem, but it is still your responsibility to make it right.

Mr. Richard Abel commented on some of the resolutions being discussed tonight. With the mayor's election if the county does not do it, we will have to pay for it. The police promotions list should be included in the resolution.

Ms. Andrea Granata commented that we should try and keep spending down. The utility pole on Burdsall and King is still in the same condition. The utility company did repairs on King Street and passed right by. Also, it is an embarrassment regarding the missing monies. Regarding sewer rent, Chris Ameigh commented there are instructions on the back of the bill on various methods of payment. She commented on various dead trees in Lyon Park near the children's play area. Burdsall Drive needs to be repaved. We do pay high taxes. Trustee Terenzi commented that we are taxed on the value of our houses.

Mr. Ceruzzi commented on whether the BOT has had meetings with the school board. Trustee Terenzi commented he sees Mrs. Capeci almost every week and he asks when are we going to start registering the kids. Mr. Ceruzzi commented on the release of sales tax by the State.

Mr. Michael Scarola, Planning Commission Chairman made the following statement:

"On 9/29, the Planning Commission was unable to conduct its scheduled meeting due to lack of quorum. This is an unacceptable situation.

I would be remiss if I didn't offer you my assessment of why it happened and provide you with recommendations for your consideration.

Assessment

The outcome on 9/29/2014 was going to happen given the composition of attendance %

by the Planning Commission members. The Planning Dept. provided me with the Planning Commission attendance records from 1/1/2013 to 9/29/2014. In Table A, I've calculated their attendance % for that time period:

With the 4 of 7* members providing 80% or less attendance % since Jan, 2013, the likelihood of a 'No Quorum' outcome is a matter of when, not if. On 9/29, only 3 of 8 members were present; M. Scarola (100%), Peter Coperine (91%) and Kevin Pellon (77%).

Another factor that contributes to lower attendance rates, and the likelihood of a 'No Quorum' outcome, is the conclusion by some members that if they miss a meeting, it's ok as there are 7 others who will attend and there's no downside to them.

Recommendations

Acknowledging there is a problem is the first step towards fixing the problem. The Planning Commission has a problem and the 9/29/2014 outcome is unacceptable. Immediate action by the Board of Trustees (BOT) is needed which sends a clear signal that the 9/29 'No Quorum' outcome is unacceptable.

- Issue a memo by 11/1, to ARB, Planning and ZBA that expresses:
 - The BOT's expectation, effective 11/1/2014, of minimum attendance % for a 24 month term with monthly meetings. Attendance records will be considered when evaluating reappointments.

In January, 2016, evaluate and consider increasing to 80%.

• As of 12/31/2014 - Initiate an annual letter to members of ARB, Planning and ZBA:

- Example: As of 12/31/2014, your attendance rate is x% for your term, which ends dd/mm/yy. The Village Board of Trustees has requested a 75% minimum attendance rate for ARB, Planning and ZBA members. Attendance records will be considered when evaluating re-appointments. Please make every effort to attend scheduled meetings. As always, we appreciate your efforts.
- The BOT to request the resignation of F. Cervinka, effective 10/15.
 - While F. Cervinka isn't the exclusive reason the 'No Quorum' occurred, his attendance record from Jan, 2013 -Sep, 2014 should be considered unacceptable.
 - 67% in 2013, 60% in 2014
 - On 10/20, the BOT to appoint C. Suma as a Planning Commissioner, effective 10/27.
- Solicit questions from each Planning Commissioner to establish standard set of questions when vetting potential appointments.

REQUESTING ASSISTANCE FROM THE COUNTY OF WESTCHESTER DUE TO CONTINUED IMPASSE WITH REGARD TO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, as a member of the Westchester Urban County Consortium (Consortium), the Village of Port Chester participates in the Community Development Block Grant (CDBG) program administered by the Westchester County Department of Planning; and

WHEREAS, through the Consortium, the Village has historically been the largest recipient of CDBG grants in Westchester County; and

WHEREAS, the United States Department of Housing and Urban Development (HUD) and Westchester County are currently at an impasse arising out of the County's implementation of the affordable housing settlement in the matter of *United States of America ex rel. Anti-Discrimination Center of Metro New York, Inc., v. Westchester County, New York;* and

WHEREAS, as a result of this impasse, communities in need, such as the Village of Port Chester, not-for-profits, and local social services agencies aiding low and moderate income residents in the Village have been denied previously allocated CDBG funding and no further funding has since been awarded; and

WHEREAS, as far back as 2011, the Urban County Council in Westchester County ("Council") which includes representatives from each of the municipalities in the Consortium, requested that HUD resolve the impasse in an expeditious manner, all to no avail; and

WHEREAS, for 2011 through 2013, the Village of Port Chester, not-for-profits, and local social service agencies were awarded \$1,673,750.00 in CDBG funds to the Don Bosco Community Center, the Open Door Family Medical Center, the Village of Port Chester, the Village of Port Chester Housing Authority, and the Clay Arts Center for vital social service programs and municipal infrastructure projects related to homeless prevention; sidewalk, sewer, and streetscape improvements; and youth development, but these funds have yet to be released, and

WHEREAS, in correspondence from the Deputy County Executive dated May 9, 2014, the County Executive has determined that the County should forego participating in a new qualification period for future CDBG funding and that the Village would be eligible to apply to New York State for participation in the Small Cities CDBG program; and

WHEREAS, such correspondence also stated that the County Executive had proposed the introduction of a Community Housing Infrastructure Program (CHIIP) consisting of a five-year, \$5 million program that would assist those municipalities with the highest percentage of low to moderate income populations that unjustly lost CDBG funding; and

WHEREAS, based on population requirements, the Village is, in fact, not eligible to participate in the Small Cities program; and

WHEREAS, the action of the County Board of Legislators is required to fund same and such approval is far from assured; and

WHEREAS, at a meeting on May 28, 2014, the Urban County Council adopted a resolution requesting that the County Executive timely make application for future CDBG funding in the next funding cycle; and

WHEREAS, the Village of Port Chester, which has done more than its fair share in providing fair housing, has been negatively impacted by the continued impasse. Now, therefore, be it

RESOLVED, that the Board of Trustees hereby supports whatever effort that will provide assistance to the residents of the Village of Port Chester with regard to community development; and be it further

RESOLVED, to that end, the Board authorizes the Mayor to forward correspondence, together with a copy of this resolution, making request on the County of Westchester as follows:

0 That the County Executive timely make application in the CDBG program so as to participate in the next qualification period so as to provide the opportunity for funding to be restored to the Village and local agencies; and

0 That County Legislator, David Gelfarb, support and lead his counterparts on the County Board of Legislators in approving the requisite funding for the proposed CHIIP program so as to provide some recompense to the Village for the loss of CDBG funding.

0 That a copy of this Resolution be forwarded to Congresswoman Nita Lowey, United States Attorney General Eric H. Holder and Westchester County Legislators.

DISCUSSIONS

Bulkhead

Christopher D. Steers, Village Manager updated the Board on Bulkhead:

We have received the contract for the bulkhead design grant award in the amount of \$225,000. We are reviewing the contract and filling all supporting comments and documents with the expected adoption of the agreement to be on the October 20th BOT meeting. Note it is a matching grant that allows us to capture certain prior expenditures dating back to April of 2013. Preliminary discussions with the department of State relating to the above have taken place. Follow up discussions as to the allowable recapture of said expenses are ongoing. Attached is a copy of the Department of State's "Work Plan" which dictates the steps / tasks throughout the project. It is important to note that the draft RFP for design now being drafted must be approved by the Department of State prior to issuing same.

On removing the exception listed in 345.14 (A) (3); additionally and having our planning staff expand upon the ability of applicants to share parking spaces 345.14 (B) (7).

Trustee Brakewood commented parking has been an issue. Our parking laws in 345-14, off street parking, truck loading and vehicular access subsection (A) (3) clearly defines that for anybody in a C2 Main Street business district, the C5 train station mixed use district and the C5T downtown mixed use traditional district don't have to provide any off street parking for their businesses, except if you are a cabaret, events or catering establishment and theaters located in any of those districts. So the Capital does have to provide parking. When they opened they leased parking for about 400 spaces. Shortly thereafter the train station put up signs for No Event Parking. The Town of Rye parking fell through and now the Capital is looking for a variance to provide zero spaces. The reality is that they were providing zero spaces from the beginning because those agreements really didn't work very well. Most people are probably parking at the Marina anyway. Why are we managing these businesses through a variance process when a zoning board has a choice of either placing a great burden on the Capital (and potentially closing it because they don't have parking) or they are going to issue the variance. These parking regulations are out of date only. People are not going to the Capital exclusively; they are going to dinner or a bar for the night. Trustee Terenzi commented the Embassy only has parking on Marvin. The Capital still rents from the Town of Rye and they have two Ravikov lots. The Capital can make a case that at least 40% of their patrons come by train. Trustee Brakewood commented if there was some analysis or some numbers that we put behind this maybe there are more establishments to be covered than the Capital.

Chris Gomez commented there is a lot of discussion regarding shared parking. Trustee Ceccarella commented that some business do not want to share their parking because of vandalism. Chris Gomez said a typical parking garage would be 300-400 spaces. Trustee Brakewood said the question is whether we should change what is in subsection (7) to allow for shared spaces.

Sidewalk Betterment Program

Village Administrative Aide Chris Ameigh commented the Board asked us to take a look at ways we might be able to simplify or help people who have been cited. We came up

with a pretty basic program. The Board will dedicate a pot of money for the homeowners who have been in violation in the past two years. We put out a bid for a dedicated company not to exceed contracts for pricing for sidewalk repair to help owners. Those issued citations should apply to the program, and then they would be eligible for 30% matching to assist with the repairs. Then the owner would either pay the Village back at a monthly rate or we would recoup those funds by some other means. This is the basic concept of the program. It is similar to the Sidewalk Betterment Program we had in recent years.

Trustee Brakewood asked if it was literally a pot of money. Village Manager Steers replied that it is a very small pot. This is a small program that addresses a specific need. It will be used for those individuals who have been cited either by code enforcement or by trip and falls or by DPW.

Trustee Adams thanked Chris Ameigh for getting back to him on the work order for the utility pole on South Regent and Westchester. Last week we attended a discussion on Ethics. I would like at the first or second meeting in November to have as an agenda item the zero dollar acceptance. We could all be in violation of this. On Boards and Commissions, there was a time they were coming before us. I still would like to hear from the Boards and Commissions who have not yet come before us. At the first or second meeting in November I would like to have a meeting with Mike Scarola. He brought up some things tonight that should be discussed in Executive Session.

Trustee Brakewood commented on the municipal center being on the agenda for October 20th. I would like as an alternative for the Board to understand the work that went into the original proposal to build out the gymnasium for the courtroom. There may have been an original design to build that out. I voted against it at that time, so now I would like to see it again. All of a sudden the million dollars for building out a courtroom and a meeting room seems better than 40 million dollars for a new municipal center.

Trustee Terenzi commented that the cost of eminent domain in the building of the new municipal center would be approximately \$2.6MM. That is what the properties are paying taxes on right now. This police station and courthouse property may be worth \$3MM. The property on Grace Church may be worth \$7MM to \$8MM. Now, by trading assessments you have \$120M in taxes. He asked Village Treasurer Douglas to show the auditor's predictions. I also want appraisals on what the properties are worth.

Trustee Marino commented that he does not want to put any more money into the police building. I also can't see building a courthouse on the other side of town. It makes sense to have everything in one place.

Deputy Mayor Trustee Ceccarelli commented on the J. C. Span report there was a figure of \$30MM. The numbers go from \$24MM up to \$30MM. He has some concerns about

the population spike and new development. Down the road we will have to pay for new sewage development. He thanked the Board of Ethics for putting together the ethics training. He congratulated the police promotes.
