II. RESOLUTION

ADDITIONAL PUBLIC HEARING ON PROPOSED VILLAGE OF PORT CHESTER COMPREHENSIVE PLAN AND RELATED ZONING REGULATION TEXT AND MAP AMENDMENTS

On motion of TRUSTEE KENNER, seconded by TRUSTEE TERENZI, the following resolution was adopted by the Board of Trustees of the Village of Port Chester, New York:

WHEREAS, the Village of Port Chester is in the process of adopting its first-ever Comprehensive Plan ("Plan) to guide future growth and preservation patterns for the protection of the public health, safety and general welfare of its citizens; and

WHEREAS, the Village Board of Trustees established the Comprehensive Plan Advisory Committee (CPAC) to assist the Board in developing the Plan; and

WHEREAS, the CPAC held a public hearing on March 21, 2012 and unanimously approved the referral of the Draft Comprehensive Plan to the Village Board of Trustees; and

WHEREAS, pursuant to New York State Village Law §7-722 (6), the Village Board of Trustees must, within ninety (90) days of receiving a recommended comprehensive plan submitted to them by a planning board or special board assigned to prepare the comprehensive plan, hold a public hearing on such proposed plan; and

WHEREAS, the Village's consulting planner, BFJ Planning, submitted a preliminary Draft Zoning Regulation text amendments and Map to the Village Board of Trustees on March 22, 2012 and held a work session with the Board of Trustees on this date as well as on May 16, 2012; and

WHEREAS, pursuant to Village Law §7-722 (5), any proposed comprehensive plan may be referred to the village planning board, in this case, the Planning Commission, for review and recommendation before action by the Board of Trustees and awaits same; and

WHEREAS, pursuant to Village Law §7-722 (5), the Village Board of Trustees referred the proposed Comprehensive Plan to the Westchester County Planning Board for review and recommendation as required by the County Administrative Code; and

WHEREAS, by correspondence dated June 18, 2012, the County provided a project review that congratulated the Village on its efforts; and

WHEREAS, public hearing was held on June 18, 2012 where the Village's Comprehensive Plan consultant team made a presentation; and

WHEREAS, all interested parties in attendance were given a full opportunity to be heard; and

WHEREAS, the Board adjourned the public hearing to July 16, 2012; and

WHEREAS, the Board desires to provide an additional hearing date on the Comprehensive Plan after July 16th to assure a full, inclusive and iterative public participatory process. Now, therefore, be it

RESOLVED, that the Village Board of Trustees hereby schedules a further public hearing on the Draft Comprehensive Plan and related zoning amendments, amended to be held at the Port Chester Village Court, 350 N. Main Street, Port Chester, NY 10573, on Monday, August 6, 2012 at the Police Headquarters/Justice Court Courtroom, 2nd Floor, 350 North Main Street, Port Chester at 7:00 p.m. ROLL CALL

III. WORKSESSION

Workshop for Starwood Capital to present their proposed zoning amendment

Ms. Maria Rigopoulos handed out to the Board the Starwood Capital proposal along with their proposed zoning amendment. Ms. Rigopoulos spoke regarding the community and why the old United Hospital site needs to be a mixed use site. Ms. Rigopoulos stated that Starwood Capital is proposing a five (5) to six (6) story building with 820 units. 5% studio, 48% one bedroom, and 47% two bedroom with retail space of 20,000sq.ft. The Board asked several questions gave comments regarding the population density and the financial impact on the community. Mayor Pilla asked for another workshop with Starwood Capital on July 2, 2012 at 6:00 pm.
