## 2015 Police Department Budget

Chief of Police Michele Powers led a discussion to review the submitted 2015 Budget and review key 2014 initiatives detailed in the Police Report.

Highlights of the discussion were:

- Police contracts for 2015 are not finalized, which may affect the salary line items
- Dispatcher salary line items for 2015 will be less than indicated, based on when the Holden regional dispatch center goes live. Estimated budget line item change can be 50% based on current schedule.
- Request to increase the over time line item to be consistent with year-over-year salary increases. with no increase in this line item, the net hours is going down year-over-year. While there is a trend for more hours due to court appearances. Suggested increase be 14% to catch up past years.

- AB recognizes there is a continued trend upwards with several of the larger budgets and is concerned the future ability to raise funds and meet correlated obligations such as pension requirements due to increased salaries can be unsustainable. AB recommends we convey this concern ASAP to BOS given several contracts are up for renewal and in negotiation now. Additionally, Princeton will want to continue to save for its future as in its past with replenishing funds used for special projects.
