## **Town of Princeton Budget**

- Monty Tech Budget review
  - o Expansion of curriculum and programs: finance, AP classes, EMT, and vet
    - Credit union to locate on campus
    - Partnership with Becker and Tufts for vet program
  - Cost reductions
    - Email switched to using gmail
    - PCs being replaced with chromebooks; chromebook repair part of student high tech repair pgm
    - Some staff changes
  - Overall, excellent budget management, <1% increase year over year</li>
    - Some new programs being funded by grants
  - AB requests
    - Copy of teacher steps and teacher population on the steps
    - Request research why the large jump in Princeton contribution FY-14 to FY15. Larger than can be explained in just increased student enrollment
- Budget
  - BOS voted a 2% increase for employees /contractors that are non-union and no special COI/CPI clauses in their agreement.
    - With this motion, salary obligations to increase ~\$30K and variable obligations for taxes/benefits is ~\$1.2K; total \$31.2K
  - o Discussion on the AB 4/7 recommendations for capital items and unfunded items
    - Defer police vehicle lease by 1 year
    - Do not undertake the Bagg Hall comprehensive engineering project as a

single expense, rather break it down to prioritized items.

- Clarifications made to the levy limit and the planned levy; differing opinion on how much ceiling there should be, especially when compared to other towns.
  - Treasurer prepared a historical table of tax rate assessment rates.
    Discussion around the year 2007-2008 tax years when taxation rate declined.
    - More discussion around the rate may/may not be the best indicator since many factors go into yearly budget and whether the rate was near the levy limit.
- Aside from the WRSD Operational Expense, with all other operational budget items considered including the salary adjustments, the town would be operating within 2.5% increase from 2016 to 2017. Differing opinion whether 2.5% is adequate to operate the town over coming years given several of the large projects.
- o Town cash reserve is ~12% of budget; deemed one of the better in the state.
- AB asked whether the ATM WRSD budget be broken apart into the 4 sub-budget items, whereby the Operational expense can be voted on indepently of the other 3 state calculated components. Operational expense is WRSD determined.
- Reviewed the ATM draft, Warrants 1-25. Resume review of Warrant 26-40 on Friday 4/15.

## **Planning Board Warrants**

- Reviewed 4 warrants
  - Adult Entertainment zoning bylaw. If such as business were to operate in Princeton, it would locate in the business/industrial zone on Rt 62 West with requirements for setbacks from road and from adjoining properties.
  - 3 other warrants to clarify/amend existing bylaw language
    - Amendment for food-related business now includes mobile businesses (e.g. food truck).
