## **Meeting Minutes**

- OPEB Discussion
  - Mr. Parker Elmore of Odyssey led a discussion through the study his company provided for the town of Princeton, reflecting the new GASB rules that affect OPEB planning points.
  - Several take-away points
    - Do continue to make yearly allocations, even if it is a reduction over previous years. Just stopping altogether will raise ratings firms interests to understand why
    - Don't take loans against the town OPEB trust
    - Do balance towns near-term needs with long-term obligations, by adjusting up/down yearly contributions
    - Do forward planning for Cadillac Tax for 2020 and beyond
    - Town of Princeton is ahead of many other MA towns with contributions over the past years.
    - Princeton needs to build a composite OPEB picture that factors in WRSD and Monty Tech in addition to town and PMLD obligations.
- Environmental Action Committee and Plan Discussion
  - o Intent of article is to establish a committee to only write a plan.
  - BOD needs to decide if it establishes a committee, how to structure a charter that goes beyond the plan itself, e.g. recommendations are pursued for completion; grant writing, etc..
  - o EAC to come to AC on 4/12 for Q&A with AC members
  - Overall, well intentioned article. Some concerns expressed about potential overlap with other committees and boards in town, if this committee is charged with setting policies at a future date.
- Discussion for revisions Operating and Capital Expense worksheets
  - Nina, TA, led discussion of the updates made to the current version of the budget and capital worksheets.

- Discussion to combine building infrastructure study with the maintenance study as part of the Community Compact Agreement. Needs researched.
- Draft ATM Warrant Articles Discussion, referencing Version 7 from 4/10/2017
  - Nina, TA led a discussion of the new and revised articles in the draft 7 ATM
     Warrant
  - o AC to look over WRSD and TPS septic system report
