Meeting Minutes

Meeting Started at 6:00 PM

AC Minutes for 4/7, 4/11 and 4/17 approved

Jimmy O'Coin led a discussion for the Police department request for a new cruiser. Department to downsize fleet from 5 to 4 vehicles. Of the 4, 1 is dedicated to the Police Chief, the other 3 are fleet for officers performing duties. 2 of the 4 have >100,000 miles and high idle hours. Request is to replace one of the two vehicles with >100,000 miles. Maintenance and repair bills for each vehicle are less than \$3000 / year. Cost of a replacement cruiser estimated at \$48,000

Judy Dino introduced William Dino from the Princeton Fire Department Ambulance Service. William led a discussion on the differences of Advanced Life Support and Basic Life Support, how Princeton services ALS/BLS calls. William relayed a summary statement that, for improving the chance of surviving the most serious emergency incidents, community CPR and stroke education would be most effective and least costly first step, before considering adding weekend ALS staffing. He did feel that weekend BLS staffing would serve to improve weekend response to calls.

John Shipman relayed information that Fire Chief is reviewing available options to reduce total spend for two replacement fire-trucks. Some used inventory has recently come to market that appears to be a very good fit.

George Handy led a discussion on the current version of the town budget (operating budget, capital budget, revenue/levy). George's analysis has shown high growth in town operating budget, while school budget has been inline with the economy. George provided an alternative recommendation of the budget, which is a reduction of \$346K that would benefit the town to borrow funds with less impact to taxpayers for the forthcoming facilities

improvements the town needs to address. AC will reconvene on April 26th to decide on George's recommendations.

AC took up the vote for the 5 Facilities articles in the draft v8 of the warrant. SB asked AC to vote on the order as currently listed. FSC chair Karen Cruise answered several questions about the amounts in the articles, what is included in the amounts, and preferences of the FSC for articles on the warrant. AC voted 1-Y, 5-N, 1-A for the current order (1,2,3,4,5). AC suggested re-ordering the articles 1,4,2,5,3; AC voted 6-Y, 1-N, 0-A.
