Review Warrant Articles

Article 3 (operating budget)

The most recent changes were highlighted and discussed. The Town Building Operations item was reduced by \$8k. The \$8k was moved to Article 18 (Temporary Office Space/Bagg Hall project). A concern was raised regarding the \$40k addition to the Town Administrator Expenses. The intent is to provide money to engage contractual project management resources as needed to move along individual projects. It was pointed out that the \$40k was added in expenses and not for salary for a town position, however additional funds were added to benefits line item should they be needed. A concern was raised that the money could be used in other ways with Select Board approval.

Article 18 (Temporary office space lease, renovation, and moving expenses)

The article is a request for \$158k for leasing, renovation, and moving expenses to relocate town offices during the Bagg Hall stabilization project. Comparative budget information from a similar projects in Upton and Hopkinton was presented.

VOTE: Y-4, N-1, A-1 (AC recommends approval)

Article 20 (Infrastructure Stabilization Account)

The article is a to transfer \$130k from free cash to the Infrastructure Stabilization account and to raise and appropriate \$100k to be put into the Infrastructure Stabilization account. While there were no objections to transferring the \$130k from free cash, concerns were raised about the additional \$100k in

spending when the funds would not be appropriated for use until some future date.

Articles 21, 22 (Citizens' Petition to change bylaws)

The article is a request to change the Town Bylaws to change the Advisory Committee to a Finance Committee with expanded responsibilities and authority. After comments made during the May 1st Public Hearing, it is likely that there will be motions on the floor at Annual Town Meeting to amend the

Articles as written in the warrant.
