## FY08 Warrant #25

### **Minutes**

#### Assignment and Assumption Agreement- Four Corners Property

Town Counsel asked the Board to sign an Assignment and Assumption Agreement that would allow covenants in the contract between TPL and Transformations Inc. to be assumed by the town. Joe moved to sign the Assignment and Assumption Agreement. Alan seconded. All were in favor (3-0).

Alan moved to approve the sale of \$450.00 for a (2) two body lot, known as space 16A in Woodlawn Cemetery for Phillip M. Connors. Joe seconded. All in favor (3-0).

#### **FY09 PILOT Funding Letter**

The Board signed the PILOT funding letter to Senator Panagiotakos, urging his support of the House version of \$30.3 million for FY09 PILOT funding.
