Town Administrator's Report: J. Ritter reported that the next meeting of the Board of Selectmen will be held on Tuesday, January 20, 2015 at the Senior Center starting at 7:00p.m.

The Town received notice from Governor Baker that Rehoboth will benefit from an increase in Chapter 90 Funding in the Amount of \$307,896 for a Total of \$923,689 annual for road repairs.

Last week the Board approved setting the Annual Town Meeting Date to be Monday May 11th. Notice was sent to all Departments and a Press Release issued. A 1st Draft of the Warrant has been completed.

Budget sheets have been sent to all Departments which includes a revised budget schedule and submission date.

The Town received a copy of a Press Release from National Grid which cautioned residents from releasing sensitive account information this notice has been posted to the front page of the Town's web site.

There was Department Heads meeting last Thursday morning.

The Selectmen's Office has been contacted by several residents about the poor sound quality of the Planning, Conservation and Selectmen's meetings. Signs are now in place in front of the microphone reminding people to speak up.

The Town received a call from Dighton Selectman Patrick Menges who has invited the Rehoboth Board of Selectmen to meet with them as part of the quarterly meeting schedule. It was agreed that the Rehoboth Board of Selectmen will meet with the Dighton Board of Selectmen in Dighton on Wednesday, February 11th at 7:30p.m.

Zoning Bylaw Review Committee is scheduled to meet on Wednesday, January 28th at 6:00p.m. in the Senior Center.

All easement documents have now been filed at the Bristol County Registry of Deeds regarding the temporary construction easements needs for the culvert repairs at the Wheeler Street Bridge. The release of the bid documents and advertising by Mass Department of Transportation should take place in a couple of months.

Also, filed at the Bristol County Registry of Deeds is a gift of land approved at the Annual Town Meeting at 215 Molton Street. J. Ritter will prepare a letter of thanks.

Finally, on Thursday, February 5th Town Counsel and Dean Harrison from the Neighborhood Corporation will be meeting to discuss initial lease terms for the former Anawan School.
