Dear Mr. Palm and Ms. Bourdreau:

Please find the attached enforcement order addressing the wetlands violation at 185 Jefferson Avenue in Salem. The Massachusetts Wetlands Protection Act (M.G.L.ch.131§40), its associated regulations (310 CMR 10.00), and Salem's Wetland Protection and Conservation Ordinance (ch. 50) state that wetlands may not be altered, dredged, filled, or removed without a valid order of conditions from the local Conservation Commission. Any violation of the act or the ordinance may result in enforcement action including up to a \$200 fine per day, per violation. Furthermore, the responsible party may be required to restore any unlawfully altered wetlands.

FINDINGS

On March 6, 2012 the Conservation Agent, in the presence of Eric and Darren Palm, verified that an area subject to the Wetlands Projection Act and Salem's wetlands protection ordinance, located on the portion of 185 Jefferson Avenue that abuts 61 Jefferson Avenue, had been unlawfully filled. Between the March 22 and April 12 Conservation Commission meetings, members of the commission visited the site individually to verify the presence of fill.

Eric Palm appeared at the April 12 commission meeting with his hired wetlands consultant, John Dick of Hancock Associates. Mr. Dick presented a plan dated April 27, 1997 titled "Wetlands Map", showing surveyed elevations on the subject property and confirmed that significant fill had since been placed on the site.

Although the commission finds the owners of 61 Jefferson Avenue, Eric and Darren Palm, to be responsible for the unlawful fill, this enforcement order is issued jointly to National Grid, owner of 185 Jefferson where the fill is located. The commission expects National Grid to provide reasonable access for the assessment and restoration of the altered area and to take appropriate steps to secure the property to prevent future unlawful activity.

REQUIRED ACTIONS

In order to address the unlawful fill, the commission issues the attached enforcement order. The following actions are required as part of said order:

- 1. Within seven (7) business days of the issuance of this order, all vehicles, equipment, and other stored materials shall be removed from the area of alteration.
- 2. Within seven (7) business days of the issuance of this order, a visible barrier shall be installed to demarcate the property line between 61 and 185 Jefferson Avenue.
- 3. Current grades and the horizontal extent of the area of alteration shall be surveyed and presented to the commission on an existing conditions plan by April 26, 2012.
- 4. In order to determine whether bordering vegetated wetlands are present, a detailed assessment of vegetation, including no fewer than three (3) transects, shall be conducted in the area beyond the fill, by April 26, 2012.
- 5. A detailed plan for the restoration of the area of alteration shall be submitted to the commission for review and approval by April 16, 2012.

Upon approval of a restoration plan, the commission may issue a new or amended enforcement order requiring implementation of the plan, installation of security fencing, and submittal of an after-the-fact notice of intent.

Each day or portion thereof of continuing violation shall constitute a separate offense.
