
If I don't make it to the meeting next Thursday, the W-2 Box 14 retirement amount not only effects the Mass Return as SS payment but it effect the Federal Return as well. When preparing the taxes for Salem workers, if an amount as retirement was posted in Box 14, we also checked off Form 8880. The System will calculate any credits and posts the credit on line 50 (Page 2) on the form 1040.

Any preparer not knowing what box 14 amounts were would not do any of this and the taxpayer would not get credits on both the Federal and Mass. State return.
