17	Chairman Tombarello acknowledged the letter the board received from Brenda Copp
18	regarding her resignation from the Board of Selectmen effective November 4, 2013. He
19	asked the remaining members about how they felt about filling the open position.
20	Selectman Nicolaisen asked whether the position should be filled since they have in the
21	past. Selectman Devine added in the years past they didn't replace anyone in the
22	position. Chairman Tombarello asked the other members to help and come into the
23 24	office more often to sign bills and correspondence knowing they will be short a member. Consensus of the board is to not fill the position at this time and the board encourages
25	the public to contact the office if they feel differently and would like the position filled.

27	Selectman Devine mentioned to the board that he attended the budget committee
28	meeting last night but the budget wasn't acted on since Chief Gordon was not present.

32	Vice Chairman; seconded by Selectman Treanor. Motion passed unanimously.

34	Chairman Tombarello asked that Mrs. Copp's list of departments she was liaison to be
35	talked about at the meeting on Monday night.

39	The board discussed the documentation received from the Department of Revenue and
40	needed to make decisions on how much to put into the Town's overlay and how much
41	of the unreserved fund balance to apply to the tax rate. Ms. Blaisdell provided the
42	board with a number of scenarios to consider. The consensus of the board was to put
43	\$40,000 into overlay and to keep the minimum of 5% in the unreserved fund balance

14 15	applying approximately \$311,000 to help reduce the tax rate. This left a rate of \$27.08/\$1,000.

1 8	(e) Litigation. Selectman Devine seconded. Roll call: Devine – aye, Nicolaisen – aye,
