16	Selectman Tombarello called the meeting to order at 7:00pm.

18	Pledge of Allegiance was done.
19 20	Public Comment
20 21	Selectman Tombarello stated this was going to be a scheduled day for Donna Green to come
22	in as a representative of the TRSB but the BOS have decided that Dr. Metzler will be asked
23	to come before the BOS 2-3 times and Kelly Ward, the Vice Chair of the TRSB will be asked
 24	to come in 2-3 times per year and Donna Green will be asked to come in 3 times per year.
25	This would be 8 times per year instead of 12.

27	NEW BUSINESS
28	Review of Selectmen's Meeting Procedures
29	Selectman Tombarello read the Meeting Procedures so that the public is aware of the
30	format of the meetings. Selectman Tombarello said the meetings are typically held on
31	Monday's at 7pm, however is it up to the Board to combine 2 meetings if the agenda is light.
32	He also said there are times that a special meeting is needed in addition to the regular Monday night meetings, Page 2 Selectman Daying read the proceedures and on the 2rd line
33 34	Monday night meetings. Page 2 Selectman Devine read the procedures and on the 3 <sup>rd</sup> line the words via date stamp were removed.
35 35	Lynne is proposing to remove the last sentence of paragraph 3 under the Agenda Requests
36	and Appointments with the Selectmen. (Board members must submit late items to the [1] March 21, 2016

- agenda, but these items must be considered as new business for scheduling purposes, must
- be in writing and must state the purpose of being late.)
- 39 Selectman Goldman asked if the Chairman has to approve all agenda items and if what
- 40 would happen if a Board member had something they wanted to discuss and the Chairman
- didn't want to. Lynne said the Board member can bring it up under new business. The
- 42 Board agreed.
- 43 Lynne is requesting to add the word "posted" in the first line of the third paragraph to read
- 44 Visitors may be permitted to speak on any matter properly posted on the agenda before the
- 45 Board,.....
- 46 Selectman Tombarello suggested that the first line of paragraph 6 under the Procedures
- 47 During Meetings to read Public comment of town operations and programs are encouraged.
- 48 There was a change to paragraph 2 under Time of Meetings to read "Any member of the
- 49 Board expecting to be absent or late shall notify the Chairman or the Town Administrator
- 50 prior to the beginning of a meeting".
- 51 There was a change suggested under the Minutes section to line 5 to read Magnetic and/or
- 52 digital recordings of meetings taken..... Also in the last sentence the wording "shall be" will
- 53 be removed.
- These will be adopted by the Board of Selectmen on March 28, 2016.

## 56 Discussion regarding Fremont Rd Bridge and Phillips Rd. Bridge projects

- 57 Lynne wanted to update the Board in regards to the Phillips Rd. Bridge. Artie is speaking
- with Steve Keach in regards to this, however he is not the bridge engineer. She is asking
- 59 the Board if they are okay with moving forward with the predetermined plan. The
- 60 consensus of the Board is yes to move forward.
- 61 Lynne stated this will repair the culvert that is currently there and a footing will be put at
- 62 the bottom. She said this an approved fix by the State of NH to be removed from the red
- 63 list. Lynne asked the opinion of the Board as to whom they would recommend for
- 64 engineers. Lynne mentioned Hoyle Tanner and is this someone they should be contacting
- or should this go out to bid in search of a different engineer. Selectman Tombarello said he
- 66 would be in favor of going out to bid because the job is expected to be over \$5,000.00. The
- 67 rest of the Board agrees. Lynne said they have applied for a grant for this as well as a
- request to update the old estimate that was given by the state. She feels the original
  request should be withdrawn as they are now working on a temporary repair at this time.

- 71 Lynne said the update on the Fremont Rd. Bridge is there is a scouring issue that needs to
- 72 be addressed this year as well. She also said the engineer should be involved with both
- 73 bridges.

- Lynne asked the Board if they have goals and objectives for the 2016 year on any subject.
- 76 Lynne mentioned the Wage & Salary Committee meeting, building renovations, and project
- infrastructure. Selectman Goldman stated he would like to see the upstairs floor refinished.
- 78 Lynne also suggested asking department heads if they have goals and objectives as well.
- 79 Selectman Tombarello asked Lynne to bring up the information in regards to the kitchen
- 80 renovations that was discussed a few years ago. Selectman Devine said he'd like to see the

- 81 back parking lot of Town Hall be fixed. Lynne also encourages the public to come in under
- 82 public comment and voice their opinion as well. Selectwoman Buco feels the Wages &
- 83 Salaries should be looked into. Selectman Goldman said he would like to look into an
- 84 offsite server as well as leasing computers. Selectman Treanor feels the downstairs offices
- 85 are a priority.

- Sandown's zoning ordinances and wanted to be sure Allenstown was okay with it and theyare.

- 104 Lynne said in December the Town received a letter from Busby Construction in regards to
- the 2015 proposed plan. She said they are willing to extend all unit prices into the 2016
- season. Lynne asks the Board if they want to extend the contract with Busby or shouldthis go out to bid. Selectman Tombarello feels it needs to go out to bid because of the
- amount of the job. The rest of the Board agrees as well.

- 110 Tomabrello said a few years ago they didn't because Busby extended their 2012 contract
- 111 for the next few years.

- 113 Lynne said that on December 28<sup>th</sup> the Board made a motion to declare a portion of School
- House Rd. a fire lane. Lynne feels there should be more of an agreement with the Mr. &
- 115 Mrs. Ryan in regards to this. She asked the permission of the Board to contact Town
- 116 Council for advice in regards to this. She would look into having this recorded at the
- registry of deeds as well. The consensus of the Board is okay with this.
