- and he didn't budget for it for next year. He figured out 180 days x \$21.77 per hour for a
- total of \$3,918.60 and he is not asking for a 2% increase.
- 81 *Motion by* Brenda Copp to change the Payroll line to \$395,300.69.

- 83 In Favor, Dawn Nicolaisen, Bruce Cleveland, Lauren Cairns, Brenda Copp, Jon

- 36 Jon Goldman asked if the Sergeant's position will be filled by January and Chief Gordon
- 87 said yes he is in the final process of awarding the position. Bruce Cleveland asked about
- the Tuition Reimbursement line and Chief Gordon said they allow \$750.00 per person
- 89 knowing that all officers won't use it. Dawn Nicolaisen asked if they can use more than
- 90 that and Chief Gordon said if he has allowed it in the past but it has to be okay with the
- 91 Union as well.
