21	Lee Dube asked the Board to review the minutes of Wednesday, October 21, 2015.

27	Cindy Buco arrived at 7:40 pm.

29	The Plumbing Inspector 4241-22 budget was put on the table for discussion.
30	This budget is being presented by Gary Paradis. Michael Costanzo asked about the increase in the Phone
31	line and Gary said it has been under budgeted for the past few years and was caught this year. Tony
32 33	Piemonte asked about the supplies being shared with other departments and Gary said no his supplies are for code books and permits. Michael asked about the new Seminar line and Gary said that is a new line a
34	he would like to attend a seminar and gain additional knowledge.
35	Motion by Tony Piemonte to accept the Plumbing Inspector budget with Gross Expenses of \$7,850.00,
36	Revenue of \$6,000.00 and Net Expenses of \$1,850.00 pending further review.

Michael Costanzo asked about 100% of the budget 43 being used every year and Carroll said they are trying to expand and trying to get the grass to grow at the 44 Wells Village Rd. Cemetery and the increase in the supply line is for loam and fertilizer, gravel and lime. 45 Dean Webster asked how the Trust Fund works and Carroll said it is not part of the budget. 46 Motion by Michael Costanzo to accept the Cemetery budget with Gross Expenses of \$3,801.00, Revenue of 47 \$0.00 and Net Expenses of \$3,801.00 pending further review. 48 Seconded by Dean Webster 49 In Favor Lee Dube, Tony Piemonte, Dean Webster, Cindy Buco and Michael Costanzo. 50 Motion passed unanimously 51 52 The Highway Operating budget 4312-26 was put on the table for discussion 53 Lee Dube said there was confusion in regards to the Payroll line when the budget originally came before 54 the Budget Committee. Lee said he spoke with the Finance Director and she said the payroll detail amount 55 was not carried forward to the Payroll line in the budget. The total Payroll line should be \$183,456.00. 56 *Motion by* Lee Dube to accept the Highway Operating budget with Gross Expenses of \$587,826.00, 57 Revenue of \$100.00 and Net Expenses of \$587,726 pending further review. 58 Seconded by Tony Piemonte 59 In Favor Lee Dube, Tony Piemonte, Dean Webster, Cindy Buco and Michael Costanzo. 60 Motion passed unanimously 61 62 The Recycling budget 4326-31 was put on the table for discussion 63 Lee Dube said there was a question on this budget when it was originally presented in regards to the Dues 64 NRRA line. He stated this line has to do with the town population and the 3B line in the other budget has 65 to do with the membership population. Lee also said there was a question in regards to the Revenue line 66 and that is split 50/50 with another budget. Michael Costanzo questioned the expected Revenue amount 67 and Lee said this is what is projected to be taken in next year and Artie is ok with this amount. 68 Motion by Lee Dube to accept the Recycling budget with Gross Expenses of \$50,975.00, Revenue of 69 \$25,000.00 and Net Expenses of \$25,975.00 pending further review. 70 **Seconded by** Dean Webster. 71 In Favor Lee Dube, Tony Piemonte, Dean Webster, Cindy Buco and Michael Costanzo. 72 Motion passed unanimously 73

/4	Lee Dube asked the Committee to talk about setting the date for the Public Hearing. He said the posting
75	has to take place 7 days in advance of the meeting and they need to consider the weather as well. He said
76	the last day for warrant articles to be submitted is January 8, 2016 and January 19 th is the last possible day
77	to hold the Public Hearing. Lee proposed the date of January 12, 2016 with a snow date of January 19,
78	2016 with a posting of January 5, 2016. Michael Costanzo is concerned in regards to holding the snow date
79	for the last day possible to hold this and asked if the snow date can be January 14, 2016. Cindy Buco asked
80	to post 2 dates at the same time. Lee said he will check with Lynne in regards to how the posting should
81	read and he will update the Committee next week.
82	
83	Lee Dube stated the next meeting will be next week, November 4 th at 7:30 and the budgets that will be
84	discussed are the Library, Insurance, Government Buildings and the Executive budget.
85	
86	Motion by Tony Piemonte to adjourn.
