14. Mrs. Rosenau made a motion to accept the minutes for the commission meeting of 4/4/2019. Motion

- 30. Mrs. Rosenau informed the Commission she received an e-mailed report on the Red Barn that has
- 31. been passed on to Town Hall for printing. Once printed, the report will be distributed to the

- 39. Paranormal NH: Mrs. Dupouy has received e-mails from Paranormal NH for the upcoming scheduled fundraising events. The Commission needs to coordinate with the Old Meetinghouse.
- 40. Mrs. Dupouy will inquire as to whether a Commission Member is needed at the requested pre-
- 41. event dates requested by Paranormal NH at the sites where the events will take place.

43. Submarine History Presentation: Commission Member Peter Koester has volunteered to present a

44. multi-media presentation on the history of the United States Submarine Force in Town Hall for use

45. as a fundraiser in November.

49. Introduction: Mrs. Gaudreau introduced guest Paul Wentzell to the members of the Commission.

50. Paul has worked with Mrs. Gaudreau on researching stone walls in Sandown in the past and has

51. expressed interest in being appointed to the Commission.

52. Mrs. Gaudreau made a motion to invite Paul Wetzell to be appointed as an alternate member of 53. the Sandown Heritage Commission. Motion was seconded by Mrs. Dupouy. So voted by the

54. Commission members.

56. Project Updates:

57. Mrs. Rosenau updated the Commission on the Red Barn report she had received. The barn is

58. estimated to have originally been built in 1830. The report recommends the restoration of the barn 59. in three steps:

- 60. Clean out the interior and install new supports under the floor.
- 61. Repair the roof and cupola.
- 62. Replace/repair the barn walls and siding.
- 63. Additionally, the barn needs to have safety features installed, including stairs to replace 64. the wooden ladders and railings for ease of access to the upper floor.
- 65. Mrs. Gaudreau informed the Commission that the Conservation Commission has approved the use
- 66. of a metal detector in the vicinity of the Red Barn. The detector scanning is tentatively scheduled for
- 67. Friday, 24 May, time TBD by the Conservation Commission.

69. Old Business:

- 70. Mrs. Rosenau informed the Commission about the feasibility of utilizing a grant from Eversource to
- 71. install solar panels at the Red Barn. It has been determined that given the space requirements, this 72. is not technically feasible.
- 73. There are other grants provided by Eversource that could be utilized to help restore the
- 74. Hearsehouse/Outhouse. This building needs to be surveyed (as was done with the Barn) to
- 75. determine what is required.

77. New Business:

78. Mrs. Gaudreau proposed creating a Sandown Heritage Commission (SHC) Banner (6' x 3') for use 79. at Commission events and fundraisers.

81. Mrs. Rosenau informed the Commission she received an e-mail regarding a conference where 82. instruction for applying for various grants was available.

- 83. Mrs. Gaudreau remarked that the Commission needs to look into applying for grants to cover
- 84. restoration of the town depot.

86. Mrs. Gaudreau suggested the Commission organize a Town Stone Structure walk for interested 87. individuals.

89. The Board set the date and time for the next Heritage Commission meeting for Thursday, 6 June 90. 2019 at 7:00pm.

92. **MOTION:** Mrs. Dupouy made a motion to adjourn. The motion was seconded by Mrs. Gaudreau.
