Assistant Town Clerk, Marianne Moses, called the roll.

With 40 members present a Quorum is met.

Moderator Robert Long stated that several members called to say they may be late arriving this evening.

Moderator Long also stated that the Finance Committee plans on meeting several times this week, Tuesday, Wednesday and Thursday and possibly Saturday in order to get the budget ready for Town Meeting next Monday, June 25<sup>th</sup>. However, members should make themselves available to attend additional sessions of Town Meeting next week, just in case it is necessary to meet more than once.

Mr. Long reminded members that they have already voted to take Articles 34, 35, 37, and 38 out of order, so they will be the first articles heard this evening. When those articles are completed, he will ask that there be a motion to take Articles 3, 4, 5, and 11 to be taken out of order and reminded everyone that Articles 7, 12, and 13 are still on the Table.

Mr. Kenneth DePatto, Vice Chairman of the Finance Committee, reviewed the FinCom report and notified members that there was an oversight of \$300 in calculations on Article 3, which the Moderator will explain when the Article is brought to the floor.

# Article as written:

<u>Article 34.</u> To see if the Town will vote to add the following new section to the Town of Saugus Charter:

ARTICLE 2 SECTION 35B. ANNUAL TOWN AUDIT

The Board of Selectmen will be responsible to hire the auditing firm to conduct the state mandated annual independent audit for the Town of Saugus.

As part of the process to procure services, the Selectmen should determine in advance the requirements and objectives of the audit along with monitoring the progress of the audit. The audit should have three (3) components including an opinion, followed by financial statements, and a separately provided management letter.

The results of the audit will immediately be provided to the Selectmen and the Town Manager. It will be the responsibility of the Town Manager to address any concerns raised by the audit in a timely manner. (Board of Selectmen)

Moderator Long explained that there will be two amendments to this article. The first one as suggested by Town Counsel, John Vasapolli to insert language at the beginning of the Article, striking out "To see if the Town will vote to add the following new section to the Town of Saugus Charter" and insert "To see if the Town will vote to petition the Legislature to adopt special legislation to amend the Town Charter of the Town of Saugus by adding the following section:".

The second part of the amendment, as suggested by the Finance Committee, is to amend the first sentence in the last paragraph to read as follows: "The results of the audit will immediately be provided to the Board of Selectmen, Finance Committee and the Town Manager".

Mrs. Goodwin moves, as a courtesy, to makes a motion to amend Article 34 as stated above.

ARTICLE 2 SECTION 35B. ANNUAL TOWN AUDIT

The Board of Selectmen will be responsible to hire the auditing firm to conduct the state mandated annual independent audit for the Town of Saugus.

As part of the process to procure services, the Selectmen should determine in advance the requirements and objectives of the audit along with monitoring the progress of the audit. # Article as written:

**Article 35.** To see if the Town will vote to accept the provisions of Massachusetts General Laws Section 34 of Chapter 176 of the Acts of 2011. Section 34. Said section 20 of said Chapter 32, as so appearing, is hereby further amended by striking out subdivision (6) and inserting in place thereof the following subdivision:

(6) Retirement Board Members Compensation. – The elected and appointed members of a city, town, county, regional, district or authority retirement board upon the acceptance of the appropriate legislative body shall receive a stipend; provided, however, that the stipend shall not be less than \$3,000 per year and not more than \$4,500 per year; provided, further, that the stipend shall be paid from funds under the control of the board as shall be determined by the commission; and provided, further, that an ex-officio member of a city, town, county, district or authority retirement board upon the acceptance of the appropriate legislative body shall receive a stipend of not more than \$4,500 per year in the aggregate of service rendered in the active administration of the retirement system. (Saugus Retirement Board)

(BMS-MSBA Building Committee)

**Article 38.** To see if the Town will vote to appropriate, borrow or transfer from available funds, an amount of money to be expended under the direction of the School Building Committee for additional remodeling at the Belmonte Middle School in Saugus, Massachusetts, including the payment of costs incidental or related thereto (collectively, the "Projects"), which proposed repair projects would materially extend the useful life of the school and preserve an asset that otherwise is capable of supporting the required educational program and for which the Town may be eligible for a school construction grant from the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any project costs the town incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Town. Any grant that the Town may receive from the MSBA for the Projects shall not exceed the lesser of (1) a percentage of eligible, approved project costs, as determined by the MSBA, or (2) the total maximum grant amount determined by the MSBA. (BMS-MSBA Building Committee)
