Saugus Board of Selectmen February 10, 2016

The Saugus Board of Selectmen met on February 10, 2016 at 7:30PM in the Town Hall Auditorium, 298 Central Street. Present: Selectmen Scott Brazis, Jeffrey Cicolini, Jennifer D'Eon, Mark Mitchell and the Chairman Debra Panetta.

Invited guests: Justin Tabbi

Justin Tabbi was present and the Board thanked him for all his volunteer work and presented him with citation.

Correspondence:

1.) Casa Vallarta, 114 Broadway re: request to return application to ABCC for reconsideration. Attorney Richard Magnan, 194 Central Street was present and explained the supplemental

documentation requested by the ABCC and requested the Board resubmit for reconsideration.

Selectman Cicolini moved to resubmit application to the ABCC for reconsideration. Chair seconds 5-0.

The Chair requested to take a couple of agenda items out of order.

<u>Manager's Report:</u> Appointment to the Saugus Council on Aging.

The Chair said the Manager has recommended Judy Worthley.

Selectman Brazis moved to confirm the appointment of Judy Worthley to the Council on Aging to expire December 31, 2018. Chair seconds.

Selectman D'Eon moved to take Old Business: Hilltop update out of order. Chair seconds 5-0. <u>Old Business:</u> Hilltop re: update on liquor license.

Attorney Peter Rossetti, 436 Lincoln Avenue was present with Dennis January, 38 Main Street. Mr. January explained since the December 8th update they have designed some plans in line with the Town's economic development plan and will be presenting to the corporate stockholders in late April and asked the Board for 90 days. Selectman Cicolini said he understands why they are requesting 90 days rather than monthly but because of the nature of the time since the license has been used would like an update in late April and asked if he could arrange the meeting with stockholders before April 27th. Mr. January said yes and informed the Board that the project will be a two year project. The Chair said they have been closed since 2013 and if the Board holds a show cause hearing and takes the license it would make it more difficult to do something on the land and agreed to extend to April 27th. Selectmen Mitchell suggested 1st meeting in May. Selectman Cicolini said they will schedule their meeting before so there will be update on April 27th.

Selectman Cicolini moved to schedule update at the April 27th meeting. Chair seconds 5-0. <u>Correspondence</u>, continued

Selectman D'Eon moved to approve the No U-Turn sign on Mader Street. Chair seconds 5-0. 3.) Roller World, 425 Rear Broadway re: request for correction of number of seats in snack area.

The Chair explained the error on application and correction to 50 seats in snack area.

Selectman D'Eon moved the Board vote to make correction of seats from 2500 to 50 seats in Roller World snack bar area. Chair seconds 5-0.

<u>7:45 PM</u> Friendly's Ice Cream, LLC, 777 Broadway, for Special Permit (S-2) to allow a drive through window, to be located at, 777 Broadway, Assessor's Plan 1036, Lots 407 & 408.

John Sypek, managing director 1 Federal St, Springfield, was present and explained the building was constructed in 1985 and the drive through opened in 1988 and are looking at re-opening it and have met all requirements of the Zoning By-Law and showed pictures of Westfield site that re-opened. The Chair said there are 2 curb cuts and asked about markings. Mr. Sypek described markings on plan submitted. The Chair asked if there will be a limited menu offered. Mr. Sypek said yes. The Chair said they did need to go before the Planning Board and the Chairman is present. Mr. Sypek said there was

question about hours and the application stated 6am to 11pm and said they are not asking to modify hours.

Any to speak in favor or opposition?

Attorney Thomas Valkevich, 99 Walnut Street was present representing property owner in favor. Peter Rossetti, Chairman Saugus Planning Board was present and said the Planning Board did have a hearing on Thursday and said there was a minor issue with conservation; the fire dept recommended the plan accommodate fire apparatus; they discussed speaker volume because it abuts residential; and the Planning Board did not feel a site visit or traffic study would be needed. The Chair asked about conservation order of conditions. Mr. Rossetti said there is an open issue regarding development in rear. Mr. Sypek said he met with conservation and said there is no violation and explained in 1985 when built they didn't close out the order and they are doing that now. Selectman Cicolini asked if it expired. Mr. Sypek said it needs to be closed out and then apply for new permit.

Selectman D'Eon moved to close the hearing. Chair seconds 5-0.

Selectman D'Eon moved to grant the request of Friendly's Ice Cream, LLC, 777 Broadway, for Special Permit (S-2) to allow a drive through window, to be located at, 777 Broadway, Assessor's Plan 1036, Lots 407 & 408 with the following conditions: hours of operation to be the same as restaurant hours of operation; fire department recommendation that the access / egress not to be hindered; approval of conservation commission and Planning Board required. The Chair added the following conditions without objection: any changes in plans must come back to the Selectmen and Planning Board for approval; Building Inspector's comment that a Special Permit is required by the Zoning Board of Appeals per Article 7; must have Building Inspector approval and Planning Board approval on all plans or changes of plan; and speaker volume to be monitored and adjusted as needed.
