- Mr. Crabtree moved to take up the 7:55 PM public hearing at this time. Chair seconds. Vote: 3-0.

Application is also being made for a variance to waiver the external grease trap requirement under Article IV, section 21 of the Town of Saugus Sewer Rules & Regulations. This hearing is being held under Article III, section 12 of the Town of Saugus Sewer Rules & Regulations.

Cleberson Soares, 12 Alder St. was present and explained his request with no kitchen just coffee and pastry. Mr. Serino asked about entertainment. Mr. Soares said one television. Mr. Crabtree asked hours of operation. Mr. Soares said 7AM-10PM. Mr. Serino said he is asking for grease trap waiver and asked about cooking. Mr. Soares said no cooking.

Mr. Serino moved to grant the request for Common Victualer's License and Entertainment License with the following conditions: Common Victualer's License hours of operation Monday through Thursday 7AM to 10PM, Friday, Saturday & Sunday 7AM to 11PM; seating capacity 10; Entertainment License restricted to same hours Monday through Thursday 7AM to 10PM, Friday, Saturday & Sunday 7AM to 11PM; one television; and further moved the Board grant the variance to waiver external grease trap requirement with recommendation of Health Dept. and Plumbing Inspector. Chair seconds. Vote: 3-0.

Member's motions

Mr. Crabtree: said he had no motions this evening.

- said he had opportunity to attend VFW grand opening and thanked them for the invitation and wished them luck.

Mr. Serino: said the Board met regarding the sewer bank and new ACO and explained the new consent order is basically the same except DEP deleted the requirement to maintain and operate a sewer bank and said the Town still has the same issues before us and was on the Board when we entered into this and noted DEP mandated the sewer bank or the Town would have been facing a moratorium.

Mr. Serino moved the Board vote to accept and to sign the new Administrative Consent Order handed down from DEP. Chair seconds. Mr. Crabtree speaking on the motion agreed and said in tough economic times it may help stimulate growth. Vote: 3-0.

Mr. Serino said the Board did meet and the Manager presented three options for Hamilton Street and the Board chose the option that will go before Town Meeting for a vote. The Manager said he did request a consensus from the Board. Mr. Crabtree explained the Board strongly supported the plan including sidewalks, paving and tree planting and said they are just waiting for figures. The Manager said he will have figures

soon and have an Article ready and explained the preference of the Board was a full reconstruction including curbing, sidewalks, trees and handicapped ramps and will be up to Town Meeting to vote on. Mr. Crabtree said he is in favor of full reconstruction. Mr. Serino agreed it was the best way to go. Mr. Crabtree said the public should be aware to repave street surface is a short period of time, but full reconstruction is a longer process but worth it. The Manager said the engineering will be done by the end of the calendar year and will be finished by spring next year and explained with sidewalks and trees the street will be narrowed and that will help with the speed problems and said an overlay life expectancy would only be 3-5 years, but with full reconstruction it would last 20-25 years and feel they will get good prices in these economic times.

Mr. Serino moved the Board vote to reappoint Randy Briand as Veterans' Graves Officer in the Town of Saugus. Chair seconds. Vote: 3-0.

Mr. Serino moved the Board vote to reappoint Bernie Sturniolo as Regular Member of the Zoning Board of Appeals. Chair seconds. Vote: 3-0. Citizen's Forum

Mr. Serino noted Mr. Maltais was present and informed him the Board voted to insert his Article into the Annual Town Meeting Warrant.

Mr. Serino moved the Board vote to close the Annual Town Meeting Warrant, but leave it open for the Manager until April 14. Chair seconds. Vote: 3-0.

Mr. Crabtree moved to adjourn. Chair seconds. Vote: 3-0.
