Present were: Selectmen Stephen Castinetti, Stephen Horlick, Julie Mitchell, Debra Panetta and the Chairman Michael Serino. The Town Manager Scott Crabtree was also present. Invited Guests: Appointment of Town Manager

The Chairman swore in the new Town Manager Scott Crabtree and everyone congratulated him. The Manager thanked the Board for their support and thanked the public, department heads and employees and said everyone has taken steps in the right direction to bring the community together and looks forward to serving the community. The Chair thanked everyone for coming and acknowledged Senator Sal DiDomenico and said Senator Tom McGee was present but had to leave and thanked them for coming and recognized Rep. Donald Wong and DJ Napolitano Congressman Tierney's aide present. Approval of minutes: March 8, 2012 & March 13, 2012

Ms. Panetta moved to approve the March 8 minutes. Chair seconds. Vote: 5-0.

Mr. Castinetti moved to accept the March 13 minutes. The Chair offered an amendment. Chair seconds. Vote: 5-0.

Mr. Horlick moved recess. Chair seconds. Vote: 5-0.

Meeting recessed at 8:06pm.

The Chair called the meeting back to order at 8:15pm.

The Chair said they have held the event in the past with no problem and said the request is for Common Victualer's & Entertainment only. Steven Castraberti was present and explained North Reading High School Senior Week event.

Mr. Braunstein, 3 Center Plaza, Boston was present representing Home Depot and explained proposal for 12 additional trucks and described location the vehicles would be parked / stored. Ms. Panetta moved to insert the Article submitted by Alternative Energy Committee into the Annual Town Meeting Warrant. Chair seconds. Vote: 5-0.

Ms. Panetta moved to insert the Article submitted by Mr. Stewart into the Annual Town Meeting Warrant. Chair seconds. Vote: 5-0.

The Chair said the Board will meet on April 9th at 7:00PM to close the Warrant. The Board agreed to meet in the conference room. Ms. Mitchell said she is unable to attend. Member's Motions

The Chair said the Board received copy of letter from Ann Quinlan regarding Joanne Olsen going above and beyond and read and said he would like the Board to send a letter thanking her.

Mr. Horlick moved the Board send letter. Chair seconds. Vote: 5-0.

The Chair said the MBTA hearings focused on fare increases and elimination of services that would affect Saugus and said he is happy to report the MBTA's draft plan restored services to Saugus.

The Chair said the MBTA signed off on the lease agreement for the rail trail and part of that the Board needed to send a letter to the MBTA formally requesting permission to remove the rails and he sent that yesterday.

The Chair said the Board received copy of the Open Space Plan and needs to adopt it and thanked the members of the Open Space Committee for their hard work on it.

Mr. Castinetti moved to accept the plan. Chair seconds. Vote: 5-0.

Ms. Mitchell reminded everyone of Saugus Spring Clean Up Day.

Mr. Castinetti said the DPW has informed the Board street sweeping will start; the compost program is open on Saturday and Wednesday; MWRA main work; and announced the Chamber of Commerce with CDM will be hosting an informational meeting on the water main project on Rte. 1 and that will be held on April 11 at 8AM. The Manager added that the street sweeping contract was looked at and it was determined the contractor was suppose to sweep Saugus Center & Cliftondale once a month and he made the DPW Director aware and it will be done moving forward. Mr. Horlick said he requested information on that a couple of years ago. The Manager said they are required to sweep all the streets in Town twice a year also and said that includes schools and playgrounds. Mr. Horlick said there may be other contracts that are not being lived up to. The Manager said they are reviewing all contracts and will correct going forward.

Ms. Panetta said last night the Board of Health reviewed the RESCO audit and discussed recommendations and they suggested a field trip and the Board will be invited.

Mr. Horlick said he would like to do something in recognition of Ronnie Barressi that passed away and said he was very involved in the community and asked the Board if they object to him meeting with the family to discuss. No one objected.

Mr. Horlick asked the Manager if we will be looking at tipping fees soon. The Manager said next year. Mr. Horlick said the Board wants to be involved in that negotiation.

Mr. Horlick said at last meeting the Board requested the company that services street lights to come in and said we still have issues.

Mr. Horlick congratulated the Manager and said they will work together and discussed having meetings for updates on a regular basis. The Manager said his first priority is to straighten out the budget and put an action plan together.

Mr. Horlick wished everyone a happy Easter.

The Manager said he received a call from Mr. Larson with the rail trail project and they will be walking the tracks with consultants and will let the Board know if they want to attend.

The Manager said he has been visiting offices and meeting with department heads. <u>Citizen's Forum</u>

Arthur Grabowski, Saugus School Committee said Monday is Student Government Day and invited Board Members to attend and described the program and said next year it will expand like it use to be with mock meetings etc. and said the Town Clerk will be holding a voter registration also. Mr. Serino said it used to be a great time. Mr. Horlick agreed and said he's happy it's finally being brought

back and thanked the School Committee for addressing the pink slime issue. Mr. Grabowski said food service went out to bid and it specifies the quality to be provided.
