The Saugus Board of Selectmen met on April 5, 2011 at 7:30PM in the Town Hall Auditorium, 298 Central Street. Present: Selectmen Scott Crabtree, Stephen Horlick, Michael Kelleher, Michael Serino and the Chairman Donald Wong. The Town Manager Andrew Bisignani was also present.

Invited Guests: Saugus 8th Grade Basketball Travel Team

Coach John Lightbody introduced Coach John Belveau and Greg Nickolas director of Youth & Recreation and thanked HS coaches Paul Moran, Mark Burcham and John Furey. Mr. Nickolas said Saugus is a hockey powerhouse and is trying to bring basketball to that level. Coach Lightbody read each team member's name and the Board presented each with citation and congratulated them for winning the Championship.

Invited Guests: Saugus Youth Hockey Squirt A Team

Coach Patrick Groark explained the State Tournament and they won the Tier II A State Championship and thanked the coaches Scott Brazis, Bill Heffernan and James Rago and the parents and cheerleaders. Coach Brazis thanked the Board and congratulated the 8th Grade Travel Team on their championship. Each team member was introduced and the Board presented each with citation and congratulated them.

Invited Guests: Police Chief Domenic DiMella

The Chief thanked the Board and Town Manager for the recognition and said it's not about him but about a cause and explained *Protect Mass. Children* is trying to put 3 bills before the legislature to enact tougher laws on pedophiles and abuse. The Chair thanked him for supporting his bills and said he is the 1st chief to endorse them and presented him citation from the House of Representatives. Mr. Serino congratulated him and noted he was the first recipient from the organization. Mr. Crabtree thanked the chief and said they are proud and said the chief is always out front on things and advocates and this is an example of his hard work on social issues. Mr. Horlick thanked the chief and said he worked with the Board to clean up the problems on Rte. 1 and is always helping children and the elderly. Mr. Kelleher also thanked him And said he and his staff go above and beyond their duties. The Chair thanked him for endorsing the bills he put through.

Steven Castraberti, owner / manager was present and explained the request is for North Reading post prom party. Mr. Horlick thanked him for all he does.

Mr. Serino moved to approve the 1 day extended hours of operation on the Common Victualer's and Entertainment only at Prince Restaurant and allow the business to be open for operation until 4AM. Chair seconds. Vote: 5-0.

4.) 99 Restaurant re: request for change of manager.

Zachary Gordon was present. Mr. Kelleher asked his experience. Mr. Gordon gave his background. Mr. Kelleher asked about training. Mr. Gordon said he is certified. Mr. Serino asked if he would be on premise 50 hours a week. Mr. Gordon said yes.

Mr. Serino asked if CORI was back. Their clerk said no. Mr. Serino said the Board can vote conditional and asked if application fee was filed. Their clerk said it was.

Mr. Serino moved to approve the request pending background check. Chair seconds. Vote: 5-0.

Their clerk informed the Board money owed has been paid in full.

Mr. Kelleher moved to dismiss. Chair seconds. Vote: 5-0.

Mr. Crabtree said he's happy to accommodate during these hard times, but this is an ongoing issue with this business.

Mr. Wong excused himself from the table and Vice Chair Crabtree took the Chair.

7:55 "Show Cause" Hearing for the purpose of the possible suspension, revocation and / or cancellation of the All Alcoholic Common Victualer's License and Entertainment License of Twitters Bar & Grille, LLC, 1201 Broadway, Square One Mall, for violation of laws, rules, and regulations and condition of license for failure to exercise the license and failure to notify the licensing Board.

Attorney Glen Frank, Lawson & Weitzen was present representing Twitters and requested the Board allow them 60-90 days to find a suitable candidate to transfer the license to. Vice Chair asked if he works for Lawson & Weitzen and that firm represents the Board on some liquor issues if he sees any conflict with that. Atty. Frank said no and explained the business is not a corporation and they did make a good faith effort to make the business work and invested a lot of time and effort into it and would like time. Mr. Kelleher asked if they have no intention on reopening the business. Atty. Frank said no. Mr. Kelleher asked when they closed. Atty. Frank said January 17. Mr. Kelleher asked regarding the special legislation how it ties to the mall. Vice Chair said as clarification the special legislation allowed the Board to issue an additional license to be exercised at the mall but does not give ownership to the mall, only the location where it can be exercised and said there are two issues before the Board, 1.) closing without notification to the

licensing authority; and 2.) not exercising the license. Mr. Kelleher asked to hear from the mall manager. Vice Chair swore her in. Susan Yee, General Manager was present said she's disappointed they closed and the mall was not given notification either and as soon as she was aware she called their office to let the Board know. Vice Chair swore in Lt. Giorgetti. Lt. Detective Ronald Giorgetti was present and read his report. Mr. Horlick asked if they are in process of filling the space. Atty. Frank said he has spoken to some brokers. Mr. Horlick said he wants to see businesses succeed but license holders submit a written statement that they read and understand the Saugus Liquor Rules & Regulations and would like to see something in before license renewal time. Atty. Frank apologized that proper notice wasn't given and is willing to come back with progress report. Vice Chair said the Board wants something to benefit the community and from a legal standpoint the Board doesn't want licenses unused and the Board is putting your client on notice that we intend to cancel, or revoke the license after 6 months. Mr. Serino said 90 days is reasonable and is filling to continue the hearing until then. Mr. Horlick said they should be actively looking for a new tenant.

Mr. Serino moved to continue the hearing until the first meeting in July. Vice Chair added with no objection: the Board is giving notice to the license holder as of the date it is adopted that they have six months to exercise the license or the Board will conduct further hearing at the first meeting of the Board in July and nothing in the notice will prevent the Board from exercising their power and authority under the law. Vice Chair seconds. Vote: 4-0.

Mr. Wong returned to the table and resumed the Chair.

Ms. Davison said 7 Thomas Street, Saugus.

Mr. Kelleher moved to close the hearing. Chair seconds. Vote: 5-0.

Mr. Kelleher moved to grant the S-2. Mr. Serino added with no objection: limit of four stations; and hours of operation to be Monday through Thursday 10am to 8pm and Friday & Saturday 9am to 4:30pm. Chair seconds.

Announced the compost and recycling site is open on Saturdays.

- said he received communication from the Town Clerk requesting the Board close the Annual Town Meeting Warrant.

Mr. Serino moved to leave the Annual Town Meeting Warrant open until April 11, 2011 for the Manager to submit Articles and any other submitted to the Selectmen with the proper number of signatures be inserted. Chair seconds. Vote: 5-0.

Mr. Serino moved to insert Article submitted by Theresa Lehane into the Annual Town Meeting Warrant. Chair seconds. Vote: 5-0.

Mr. Serino moved to insert the Article submitted by Jeffrey Moses into the Annual Town Meeting Warrant. Chair seconds. Vote: 5-0.

Member's motions

Mr. Crabtree: Gave update and said public officials are moving forward with looking at efficiency and saving money and will be meeting to discuss short term solutions and long term solutions and said Town Meeting voted to authorize the Board to petition the legislature for a special one time assessment and the Board did vote to do that and encouraged anyone with questions to call a Board Member or Town Manager and asked the Chair for update on the bill. The Chair said the bill was filed by him, Rep. Reinstein, Sen. McGee and Sen. DiDomenico and is in committee and they are trying to put it on the fast track. Mr. Crabtree asked he extend the Boards gratitude.
