- Mr. Horlick said this has been an issue for quite some time and thanked the Manager and residents of the area for getting this done.
- 6.) US Census 2010 re: Notification of Door to Door Census.
- Mr. Castinetti read the letter into the record as follows: "Between April and July 2009, U.S. Census employees will be visiting every housing unit in every neighborhood of your community. In order to conduct the 2010 Decennial Census, the Census Bureau must know the address and physical location of each place where people live or stay. Our Census employees will wear official identification and carry hand-held computers to capture physical addresses and their GPS coordinates. We are reaching out to police departments, local governments and civic organizations to inform the community about this important activity, thereby reducing public concern. Enclosed is an awareness poster for you to post in a public area. We appreciate your cooperation and support in educating your community. The U.S. Census Bureau Partnership Specialist working in your area will contact you in the near future to answer any questions you may have. Sincerely, Kathleen N. Ludgate, Regional Director, Boston Region."
- Mr. Castinetti said obviously this is an important event and said funding is tied to the census numbers and asked citizens to please be cooperative.
- Mr. Castinetti said there have been some issues the Board has been carrying on for some time and would like to dispose of them and said the Board requested recommendation from the Police Chief regarding 1AM closing for liquor establishments.
