

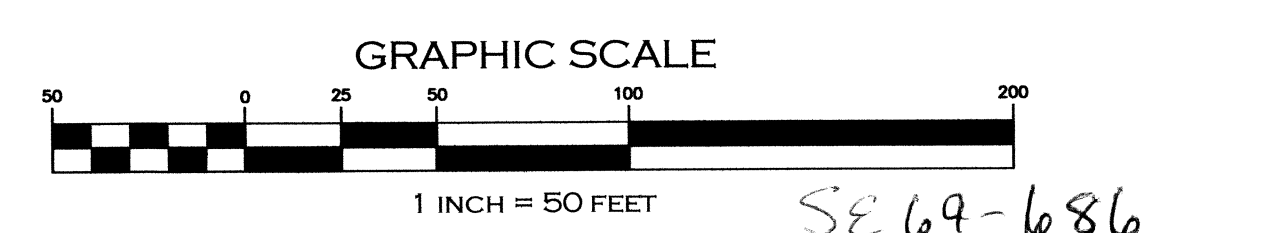
LOCATION (NOT TO SCALE) MAP
