



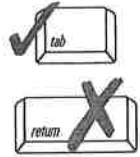

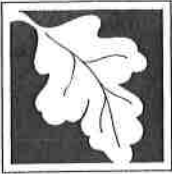

2. THE BLUEBERRY BUSHES SHALL BE MONITORED FOR 2 YEARS FROM THE DATE OF THIS CERTIFICATE OF COMPLIANCE BY THE COMMISSION AND SHALL HAVE 100% SURVIVAL RATE. ANY BLUEBERRY BUSHES THAT DIE SHALL BE REPLACED BY THE CURRENT PROPERTY OWNER. PLEASE REFERENCE THE PLAN ENTITLED "SEPTIC SYSTEM DESIGN PLAN AND NOTICE OF INTENT PLAN (LOT 38) HAYLEE COURT BY INSITE ENGINEERING, REVISED DATE JANUARY 9, 2009" FOR NUMBER AND LOCATION OF BLUEBERRY BUSHES.

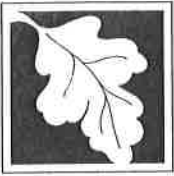
