<p>The isolated area subject to flooding is presently receiving stormwater runoff from the Proposed Subdivision and consists of about 1 acre of land. No fill will be placed in this area and there will be no loss of storage. Drainage computations (Ex.B) indicate the area is large enough to accomodate runoff from a 25 year storm for 155 minutes. Runoff from larger storms will overflow in a westerly direction as it does now and will cause no damage downstream.</p>		Exhibits A and B
