Compensatory 100 year floodplain will be excavated from an upland area immediately adjacent and at the same relative elevation as the area to be filled in the volume of 540 CF. 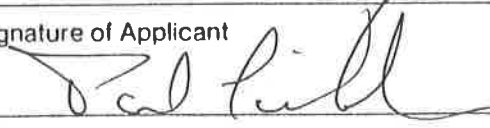
