Mr. Costa made the motion to approve the minutes of October 16, 2013, seconded by Mr. Brown LPN and so voted 2-0-1

NEW BUSINESS

Alternative Design Flow for Title 5 – 1530 Fall River Avenue - Swan Brook Assisted Living. Request to use water meter readings from another assisted living facility.

Mr. Robert Berube of Pro-Line Engineering and Mr. Mark Shane the owner of the project were present for this discussion. Mr. Berube stated in Title 5 there is no calculations for an Assisted Living; there is only calculations for Nursing Homes. For this project the apartments will not have any kitchens or laundry. There will be a centralized dining area and laundry facility for all units. Mr. Berube has designed the system based on a similar unit in Swansea. He has currently designed this system for 45gpd times 200% for a total of 90gpd per unit. This project currently needs DEP approval and Mr. Chenevert is recommending approval.

Mr. Brown LPN made the motion to approve the request to use the water meter reading time 200%, seconded by Mr. McLintock and so voted unanimously.

Mr. & Mrs. D'Amico wishes to speak to the Board regarding the water analysis results at 6 Birch Street, Seekonk, MA.

Mr. D'Amico and Mrs. D'Amico has had their well tested and it currently does not fall into DEP guidelines for acceptable drinking water. They have been to the Seekonk Water District to explain that the nitrates level are high and wishes to have Town water. The Seekonk Water District has put this street on their work list however this is not a priority according to Mr. D'Amico.

Mr. Brown LPN made to motion to send a letter to the Seekonk Water District regarding the eminent health hazard of the nitrate levels on this street and requests this street be a high priority, seconded by Mr. Costa and so voted unanimously.
