CONSENT CALENDAR

Request for the annual disposal exemption for John & Michelle Madera 12 Vernon Place, Seekonk, MA

The Board wishes to have the Assistant Health Agent inspect the establishment weekly and to request Mr. Massiwer at the next Board of Health meeting.

Mr. Costa made the motion to have the inspector make weekly inspections of the establishment and to fine the establishment \$50.00 for each violation, seconded by Ms. Oliveira RN and so voted unanimously.
