BOARD OF HEALTH
REGULAR MEETING

Mr. Raymond Grant Chairman, Mr. Doug Brown LPN, Mr. Robert Costa, and Health Agent Beth Hallal R.S.

At 4:31 PM Mr. Grant called the meeting to order.

CONSENT CALENDAR

Consider approval of Regular Session Minutes of:

Mr. Costa made the motion to approve the minutes of January 14, 2014, seconded by Mr. Brown LPN and so voted 2-0-1.

NEW BUSINESS

Discussion with Wind River Environmental regarding the written procedures for the pumping of exterior grease traps for the establishments in the Town of Seekonk.

Mr. Raul Jimenez of Wind River Environmental and Mr. Jason Sisto of the Discovery Group were present for this discussion.

Ms. Curzake informed the Board of the composite sheets from Wind River Environmental were incomplete and had several pumping from Starbucks missing. This was noticed when Jason Sisto came to the BOH to inquire the certificate of compliance. The Board wishes to have all exterior grease traps inspected monthly and pumped if the grease is 25% or more. Every establishment has a form that must be completed at the time of pumping. Mr. Jamenez has just taken over this section for Wind River Environmental and was unaware of the Boards requirements and some of the systems are pumped prior to the establishment's opening.

The Board is very concerned that if the records are incomplete for Starbucks then the other establishments must also be incomplete. The Board wishes to have Mr. Jimenez and his supervisor at the next Board of Health meeting with written procedures on how they will be in compliance with the Town of Seekonk.

Mr. Costa made a motion to have Wind River Environmental on the agenda for the next meeting to discuss the deficiencies in the inspection logs, seconded by Mr. Brown LPN and so voted unanimously.

Discussion regarding the smoke detectors and fine(s) at 37 Hiller Drive, Mr. Thomas Grasso.

Mr. Grasso did not appear at the meeting.

Mr. Brown LPN made the motion to decline the ex-parte motion for reconsideration, seconded by Mr. Costa and so voted unanimously. Since this issue is now null and void, the Board wishes to have a letter sent to Mr. Grasso stating the fine is due to the Town of Seekonk.

OLD BUSINESS

Discussion regarding the Town Nurse's position.

The Board would like to have a memorandum sent to the Town Administrator and the Board of Selectmen of their intentions of filling this vacancy.

Discussion Regarding Stipends for Board of Health.

Mr. Shawn Cadime the Town Administrator was present to discuss the stipends. In order to receive the stipends, a warrant article will have to go before Town meeting and where the source of funding will be from. The Board of Selectmen will be closing the warrant articles on the 1st of May. The Board would like to have this item on the next agenda.

Approval of the Seekonk Board of Health Regulations 11.0.0 Abrasive Blasting.

Mr. Costa made the motion to accept the Board of Health Regulation 11.0.0 Abrasive Blasting, seconded by Mr. Brown LPN and so voted unanimously.

Review of the Seekonk Board of Health Regulations 12.0.0 Nuisance Complaints.

The Board does not want to accept any anonymous complaints.

Mr. Costa made the motion to accept the Board of Health Regulation 12.0.0 Nuisance Complaints, seconded by Mr. Brown LPN and so voted unanimously.

Review of the Seekonk Board of Health Regulations 3.0.0- Sewage Disposal

The Board would like to see that all vehicles that fail the inspection have until the 31st of January to have that vehicle re-inspected by the Board. Any vehicle that fails after the 24th of January will only have 7 days for the re-inspection.

Review of the Seekonk Board of Health Regulations 9.0.0 – Dumpster Regulations

The Board would like the same information on as the septage haulers.
