At this time Mr. Grant asked to move old business before new business.

Ms. Kinniburgh made the motion to move old business before new business, seconded by Ms. Oliveira RN and so voted unanimously.

#### **OLD BUSINESS**

Discussion regarding the suspension of Peter Lavoie's license for percolation testing and septic system design in the Town of Seekonk.,

Mr. Grant, Mr. Lavoie and Ms Hallal met with Mr. Lavoie early in the morning because taxpayers were relying on Mr. Lavoie. It was Mr. Grant's intention that Mr. Lavoie come in front of the Board. Ms. Kinniburgh RN and Ms. Oliveira RN was concerned when they made the motion for Mr. Lavoie, they did not have all the information on what had transpired.

Mr. Lavoie stated on all of his plans he did certify the water line by using the dig safe and going into the basements of the house and locating the water line with a metal detector. He did not know the Seekonk Water District would email the water tie to him. At this time Mr. Lavoie is contacting the water district for the information.

Mr. Grant stated Mr. Lavoie should be on probation for six months. We are not in the business of putting people out of business. If there is any violation of the Seekonk Board of Health Regulation, the license will be revoked immediately.

Ms. Oliveira RN made the motion to put Mr. Peter Lavoie on six month probation and any violations of the Seekonk Board of Health regulations will result in immediate revocation of his license, seconded by Ms. Kinniburgh RN and so voted unanimously.

#### **NEW BUSINESS**

Review of the Definitive Plan of Subdivision Plan of Stone Ridge Due to the Planning Board by October 11, 2015.

Ms. Hallal informed the Board that additional percolation tests.

Mr. Kinniburgh RN made the motion to forward to the Planning Board with the notation of the additional percolation testing, seconded by Ms. Oliveira RN and so voted unanimously.

Review of the proposed Pond Street Sludge Landfill & Garage at 0 Pond St Due to the Planning Board by October 18, 2015

Ms. Hallal informed the Board the Attleboro Treatment Plant is expanding their sludge containment onto a parcel of land in Seekonk. This property is owned by the Town of Attleboro and had a site assignment from the Department of Environmental Protection in 1970.

Ms. Oliveira RN made the motion to forward to the Planning Board, seconded by Ms. Kinniburgh RN and so voted unanimously.

The house has 3 bedrooms. This property is not in compliance with Title 5. I am going to fine him \$50.00 per day. I have called the owner and JR has called with him. I would like the doorway to be 42" and I have spoken to Mr. Costa about this property. Currently there is a deed restriction regarding the number of bedrooms.

The Board feels the Health Agent has done her due diligence, by putting the deed restriction on this property.
