At 7:03pm Ms Kinniburgh RN called the meeting to order.

CONSENT CALENDAR

**Consider approval of Regular Session Minutes
Regular Session of April 26, 2017.**

Mr. Viera made the motion to approve the minutes as distributed, seconded by Mr. Boulay and so voted unanimously.

NEW BUSINESS

Request for a variance at 42 Hammond Street – Lee & Kathleen Alder – Mark Rodrigues – ADE

- (1) 310 CMR 15.211(1) – Setback distance between the proposed SAS and private water supply well serving this facility is 70.5' versus 100'.
- (2) 310 CMR 15.211(1) – Setback distance between proposed two compartment tank monolithic tank and private water supply well serving this facility is 26.4' versus 50'.

Mr. Boulay made the motion to approved the variances for 42 Hammond Street; the well setbacks to 70.5' from 100', and the setback distance between the two compartment tank and the well to 26.4' from 50' with the stipulation the well shall be tested prior to the installation of the septic system and every year thereafter, seconded by Mr. Viera and so voted unanimously.

Discussion – Straight UP Nutrition.

Ms. Stacey Gorbachev and Mr. Joseph Greenhalgh were present for this discussion.

Straight Up Nutrition came into the Board of Health regarding food permits at 1515 Newman Ave at the end of last year. They were informed a title 5 inspection needed to be completed on the property and the requirements for a food establishment.

A complaint was received that shakes and food items were being produced out of this facility. The Board of Health did order a cease and desist at this location. The food inspector and the building inspector went out to the establishment and they did witness a counter in place with different nutritional items set up. We did see Facebook posts advertising the food service.

Ms. Gorbachev stated the nutritional products seen are empty containers. They are still waiting for the Title 5 inspection. They are not open to the public. She has made samples at her home and offered them for her weight loss challenge to sample products. She is not selling any products and is not open to the public.

The Board has informed Ms. Gorbachev and Mr. Greenhalgh they are not to serve or give samples until the Title 5 Inspection is completed and they have applied for the necessary permits.
