New Business

A. MTG Disposal Services

Violation of the Seekonk Board of Health 9.3.2, operating a dumpster service without permits.

David Stukas, representative of MTG Disposal was present. Mr. Stuckas stated that this was not a willful act. MTG sent in their application, along with their check in December of 2016. The check was cashed by the Seekonk Board of Health. The application was then returned for missing information. Mr. Stuckas stated he brought all in the information in last week, along with a copy of the cashed check. The information was provided to Ms. Curzake, the Board of Health Secretary.

Jessica Horsman, Health Agent stated that she was unaware of this information. This was the first-time hearing this.

The Seekonk Board of Health was in favor of postponing this item pending further research, no vote taken.

B. <u>Violation of the Seekonk Board of Health 9.3.2</u>, operating a dumpster service without permits. ATE – Ameri-Tech Environmental, LLC

C. <u>Violation of the Seekonk Board of Health 9.3.2</u>, operating a dumpster service without permits. <u>Environmental Operations Management Service</u>

D. Review of Permit for Percolation testing and Septic System Design and Any Action Thereof.

Peter Lavoie – Landmark Site Design

Victoria Kinniburgh RN, stated that Mr. Lavoie falsified information that was presented to the Seekonk Board of Health. Ms. Kinniburgh stated that he neglected to locate a property that was in the aquifer district. Mr. Lavoie also incorrectly listed the wrong number of bedrooms. Mr. Lavoie acknowledged that he had made errors in the past.

Ms. Horsman asked where did the information come from that showing it was a four-bedroom home? Mr. Lavoie stated that the homeowners wanted to convert to a four-bedroom in the future. Ms. Horsman stated the plans should not have been listed as a preexisting four bed room. It should have been listed as an increase to the property.

Ms. Kinniburgh stated that there has been a previous suspension and a clear pattern is present. Mr. Lavoie's license was suspended for six months, for failure to documents a water line. This action resulted in a water line being disrupted.

If Mr. Lavoie's license is suspended, he will be allowed to finish any work that is started.

The Seekonk Board of Health was concerned that Mr. Lavoie was designing the plans and Mr. Scott Miccile was stamping off on the plans. The Board was disappointed that Mr. Miccile did not show up at the meeting. Ms. Horsman stated that disciplinary action could only be issued against Mr. Lavoie. Ms. Horsman stated that a letter could be sent to the state, whom licenses Mr. Miccile.

Motion: By Guy Boulay to suspend Mr. Lavoie's license for one year. Mr. Lavoie will have the ability to

finish his jobs.

E. <u>Discussion regarding Board of Health Cell Phones</u>

Ms. Horsman informed the Board of Health that the Region V Coalition was experiencing a \$15,000 budget cut to cell phone lines. At this time, they are looking for municipalities to turn over cell phones that are not needed. Cell phones are designated for 24-hour emergency responders only.

The Board of Health agreed that if we have cell phones that are not assigned to 24-hour emergency responders, the line should be turned off if not needed.
