### **Final Review of Articles for Warrant**

Chairman Parker stated that the Board had not voted on the animal shelter expansion. It was forwarded to the Capital Improvement Committee. No action was taken by the CIC.

A motion was made by Mr. Rice, seconded by Mr. Whelan, and it was unanimously

**VOTED**: To support Article 3 (Seekonk Animal Shelter).

Mr. McLintock was not in attendance at the time of the meeting.

Board members will present articles at Town Meeting: 1-4 Mr. McLintock, 5-8 Mr. Whelan, 9-12 Chairman Parker, 13-15 Mr. Rice, and 16-18 Mr. Cavaco.

### Update on Banna Station from the Banna Station Building Committee

Mr. Arthur Foulkes reported that the committee made a list of costs: architect - \$3,700, alternative (schematic for second floor building) - \$1,200, and EPD - \$1,600.

He said they found out there is an asbestos issue and there might be an oil tank on that property.

Mrs. Nolan will check with Mr. Lamoureux. A firm is getting an estimate on asbestos removal.

Capt. Michael Healy felt the oil tank had been removed.

Mr. Foulkes said it could be a one-story building. The Building Commissioner indicated a sprinkler system would not be necessary if it is less than 4,200 sq. ft.

A motion was made by Mr. Whelan, seconded by Mr. Cavaco, and it was unanimously

**VOTED**: To approve the contract with Blount Bennett Architects, Ltd. in the amount of \$6,600 and authorize the Town Administrator to sign.

# <u>Discussion on Complaint from Career Firefighters Regarding Call Firefighters</u> <u>Recruitment Procedures</u>

Adam Clement, President of the Seekonk Firefighters, Local 1931, referred to a letter from a former call firefighter indicating that any former member who would be interested in returning to an active member would simply have to take a physical from the doctor and be reinstated.

November 16, 2011

On Jan. 5, 2011, the Board voted to eliminate call firefighters. He questioned why the call firefighters would be hiring members back.

Mr. Clement said the letter was written by James Garrott, Call Association President, and David Sullivan. The action taken to hire four additional firefighters and eliminate four call firefighters was supported by the career and call firefighters. He does not understand why the call firefighters are trying to recruit on their own.

Mr. Whelan felt that vote was recanted and further that it is illegal to dissemble a union according to Mass. General Laws. He asked if it would be in violation of Town Charter.

Chairman Parker explained that all union contracts are subject to funding. The call firefighters' contract is still in effect and will stay in effect until it runs out.

Mr. McLintock asked why career firefighters are threatened by the call firefighters.

Mr. Clement responded that is not true. The issue is that they are trying to recruit individuals outside a process established several years ago.

Chairman Parker advised that in January the Board will meet with the Fire Chief for a thorough discussion about staffing.

He assured that the Town Administrator, Fire Chief, or Board of Selectmen are not recruiting for call firefighters.

Lt. Garrott questioned why the union was concerned about the letter. He said in past practice in the call system, they were asked by the previous Board to prepare a letter to generate interest. About two months ago, he met with Mrs. Nolan and Chief Jack regarding communication and how to õfixö the call department.

He asked the Chief if he ever sent letters to individuals who had left. The Chief responded that he had.

Lt. Garrott explained that the letter was to see if there was any interest. He intended to meet with the Chief and Mrs. Nolan after he had all the information together. He is not trying to take away from the career firefighters.

Mr. Clement said he brought this forward because he got the letter from a concerned citizen. He said the career union does not run the department, nor does the call firefighters.

Mr. McLintock said he has been asking for a meeting with the Chief since he was elected. He didnøt understand why it takes six months. He said there needs to be an open debate on how to improve response times in the south and north ends of town.

November 16, 2011

Chairman Parker said one of the reasons for the four additional career firefighters was to increase performance.

Mr. McLintock said that has nothing to do with response time since these people are all in the central station.

Mr. Garrott said that call firefighters need to be part of all discussions.

Chairman Parker said all involved will be included at the January meeting.

Mr. Alan Grocott felt the call firefighters hired as career were given special privileges.

Words exchanged between Mr. Grocott and Mr. Garrott.

Chairman Parker ended discussion.
