# MARCH 9, 2016 REGULAR SESSION

Chairman Parker opened the meeting at 7 p.m. followed by the Pledge of Allegiance and moment of silence.

#### **BOARDS AND COMMITTEE OPENINGS UPDATE**

Mr. Viera announced that volunteers are needed on the Board of Health (3 Board of Selectmen appointments), Conservation Commission (3 BOS), Economic Development Committee (1 BOS), Historical Commission (2 BOS), Property Tax Work-Off Committee (2 BOS), Zoning Board of Appeals (2 BOS), Permanent Building Committee (5 BOS), Finance Committee (1 Moderator), Recreation Committee (1 BOS), Recycling Committee (1 BOS).

### **Consider Funds for Veterans Memorial Park**

Mr. Joseph Velardo of the Veterans Memorial Park Committee said the initial amount was approved at \$105,000. They will add another bench, 332 pavers and three silhouettes for a total of \$130,782; an additional \$25,782.

A motion was made by Mr. Viera, seconded by Mr. Brady, and it was unanimously

# <u>Consider the Promotion and Swear in Lieutenant Sandra Lowery to the Rank of Captain with the Fire Department</u>

Chief Michael Healy explained the Fire Department has needed a full time fire prevention person for a long time. It will happen with this promotion. Two individuals took the test in December.

An interview was conducted by an independent panel of local fire chiefs and deputy chief.

The Chief proudly recommended the promotion of Sandra Lowery. Mr. Cadime concurred.

Board members commended her for becoming the first female lieutenant and now captain.

Chairman Parker thanked her for what she has done and what she will continue to do.

A motion was made by Mr. Almeida, seconded by Mr. Viera, and it was unanimously

**VOTED**: To promote Sandra Lowery to the rank of Captain with the Seekonk Fire Department.

Capt. Lowery was sworn in by Asst. Town Clerk Florice Craig. Her dad and niece pinned her badge.

#### **COMMUNITY SPEAKS**

Town Moderator Michelle Hines advised that David Francis resigned from the Finance Committee. He has served for many years. She wished him well.

She had interviewed Russell Horsman, who was in attendance. He is still interested. He will fill Mr. Francis' position that will expire in June 2016.

She also had two resignations from the Library Facility Study Committee - Mr. Waddington and Mr. Self. She had two appointments to fill those vacancies – Daniel Tavares and Martha Manno. Mr. Tavares is an architect and OPM Specialist and Ms. Manno is a former member of the Library Board of Trustees.

Mr. John Alves said he didn't know if any of the land to be foreclosed is buildable. He suggested the Community Preservation Committee might be able to do something with a lot instead of auctioning it off. He was thinking of affordable housing.

#### TOWN ADMINISTRATOR'S REPORT

Mr. Cadime advised that he met with District Attorney Tom Quinn. He introduced him to the staff and he met with Chief Mace. It was a good conversation about public safety in Seekonk. Mr. Cadime mentioned that he is trying to get additional monies for cameras on traffic signals. District Attorney Quinn committed to at least one camera.

Mr. Cadime said he met with the vendor of the website looking for options. He will be coming back with recommendations to move forward with upgrades.

He will begin to negotiate with police and fire.

He met with a representative of Bryant College about leadership training for Selectmen and City Councilors. It is free. He would like to have department heads attend. He is trying to get Swansea, Somerset, and Rehoboth to join.

He has been working with phone consultants to get a service agreement for the new phone system.

He attended a Library Facilities Study Committee meeting. The project is still in the initial stage.

Mr. Cadime noted that 4,421 customers (89.4%) have opted into the Electric Aggregation program. For the summer, National Grid prices may be lower than this (9.4) but will significantly increase at the beginning of the winter.

He cautioned people not to opt out. The Aggregate group will send out an educational packet to customers.

# **BOARD OF SELECTMEN LIAISON REPORTS AND COMMENTS**

<u>School and Town Consolidation Committee Report – Nothing.</u>

### VETERANS MEMORIAL COMMITTEE LIAISON REPORT

Mr. Viera announced that the dedication will be on March 28<sup>th</sup> following the Memorial Day parade. The parade will end at the park.

There's the possibility of having people park at the junior high school and bused to the park.

Mr. Viera asked about interviewing law firms.

Mr. Cadime said packets are ready for the Board.

Mr. Brady asked about the status of the light at the Public Safety Complex.

Mr. Cadime said there was a problem and the vendor had another job. Work should start within the next few weeks.

Mr. Brady stated that he was incredibly disappointed with the Tri Board meeting the other night. He felt he was at a seminar on special education. He is still not convinced with the numbers. He can't understand how the Collaborative is losing money. He felt this was the perfect time to move the Collaborative out if the Town needed the two buildings. He said it was somewhat insulting to be lectured on something that had nothing to do with town finances.

Mr. Viera agreed. It was not what he expected. He didn't realize the School Committee had another meeting scheduled.

Mr. Almeida commended the Kiwanis Club on the success of the Taste of the Town held the previous night. He thanked the Clarion Hotel for providing the space and the businesses. Approximately 150 to 200 people attended.

Chairman Parker added his comments about the Tri Board meeting. Personally, he will never agree to another Tri Board meeting unless the Board sets the rules. It will be to talk about full day kindergarten and budgets that affect the Town. It was an informational meeting on special education.

In response to people who asked, Mr. Almeida noted that the Spring Town Meeting has been held in May in the past.

Chairman Parker asked for an update on the vacant department head positions.

Mr. Cadime advised there are no new applicants for building inspector. The new hire for Conservation Agent did not accept the position. Health Agent is still open.

Mr. Almeida asked if the Town would get any financial benefits from the proposed casino in Taunton.

Chairman Parker said the Town would have to prove a casino in Taunton would impact Seekonk.

Mr. Viera said questions were raised with regard to the use of blue bags and containers.

Chairman Parker noted the blue bags pay the tipping fee.

Mr. Viera suggested the Board should talk about the landfill not being opened on Saturday afternoons.

At 8:30 p.m., Mr. Viera motioned, seconded by Mr. Brady, to go into Executive Session to discuss the discipline or dismissal of, or complaints or charges brought against, a public officer, employee, staff member or individual per M.G.L. Chapter 30A, Section 1, to discuss litigation strategy with respect to Nadeau Corp. and Blount Bennett Architects, LLC as per M.G.L. Chapter 30A, Section 21(3), to conduct strategy with respect to negotiations with the Superintendent of Public Works per M.G.L. Chapter 30A, Section 21(3), to discuss strategy sessions with respect to negotiations with the Chief of Police per M.G.L. Chapter 30A, Section 21(3), and to consider the approval of Executive Session minutes of February 10, 2016; to reconvene Open Session.

A motion was made by Mr. Brady, seconded by Mr. Viera, and it was unanimously

**VOT ED**: To approve and sign the contract between the Town of Seekonk and Police Chief Craig Mace.

A motion was made by Mr. Brady, seconded by Mr. Viera, and it was unanimously

**VOTED**: To adjourn at 9:55 p.m.
