Old business:

1. Minutes of the previous meeting were approved as written.

New business:

1. Review of warrant articles: John asked that the 26% distribution from the State be mentioned in any Committee report given under Article 1. He also asked for an update on the article currently under consideration by the state legislature raising the distribution percentages. Ron agreed to follow up on both.

Article 18 – Emphasize how our money will be used to leverage over twice as much from the State.

The Newman Ave. article was removed from the Warrant last week after the seller refused our offer. Kelley Whitmore and Willit will continue to monitor the situation.

- 4. Project signage update: Richard Wallace was not present so this was deferred.
- 5. New business:
 - a. Ron presented a bill for the appraisal of the lot at 524 Newman Ave. in the amount of \$3600.00 Of this, \$900.00 had already been paid by the Seekonk Land Trust and the remaining \$2700.00 was owed to Foster Co. The Committee unanimously voted to pay this bill out of our Administrative funds.
 - b. Tape recorder Ron has not purchased yet.
 - c. Ron will clarify the status of Bob Richardson as member from the Dept. of Parks and Recreation.
 - d. Sandy reported that a member of the CIC had indicated we should work under them. The Committee felt that we should keep the CIC informed of any projects that might be related to CIC projects, but our mandate is as a separate entity. Ron will talk to Lauren about this.
 - e. Kelley Whitmore will prepare a handout for Article 18 and Ron will put something together for the other two articles.
