- J. Hansen Last meeting R. Horsman proposed an amendment to the bylaw to be brought up on town meeting floor to include a buffer of 6 foot high evergreens around perimeter of all sites.
- S. Foulkes I dm concerned, will this be definitive enough?
- R. Horsman It is definitive as far as I am concerned.

M. Bourque made a motion that the planning board recommend adding "In addition to the minimum 10 foot landscaped buffer around the perimeter of all sites, as required in the Site Plan Review section, the Planning Board may require a tight evergreen landscaped buffer, not less than 6' high at the time of planting, around the perimeter of all sites to shield abutting residential properties if, at the Board's discretion, such a buffer is deemed necessary." to the Assisted Living Facility Bylaw at the end of special permit requirement # 6.

Seconded by L. Dunn and so voted by: Ch. Abelson, M. Bourque, R. Bennett, R. Horsman, L. Dunn, S. Foulkes.

VOTE: (6-0) Motion passes

- M. Bourque Are you going to put the amendment language in the handout so people can read while at the town meeting?
