THIS ORDER IS ISSUED ON (date) November 28, 1979

Pursuant to the authority of G.L. c. 131, s. 40, the Seekonk Conservation Commission has reviewed your Notice of Intent and plans identified above, and has determined that the area on which the proposed work is to be done is significant to one or more of the interests listed in G.L. c. 131, s. 40. The Commission hereby orders that the following conditions are necessary to protect said interests and all work shall be performed in strict accordance with them and with the Notice of Intent and plans identified above except where such plans are modified by said conditions.

CONDITIONS

1. Failure to comply with all conditions stated herein, and with all related statutes and other regulatory measures, shall be deemed cause to revoke or modify this order.
2. This order does not grant any property rights or any exclusive privileges; it does not authorize any injury to private property or invasion of private rights.
3. This order does not relieve the permittee or any other person of the necessity of complying with all other applicable federal, state or local statutes, ordinances by-laws and/or regulations.
4. The work authorized hereunder shall be completed within one (1) year from the date of this order unless it is for a maintenance dredging project subject to Section 5(9). The order may be extended by the issuing authority for one or more additional one-year periods upon application to the said issuing authority at least thirty days prior to the expiration date of the order or its extension.

5. Any fill used in connection with this project shall be clean fill, containing no trash, refuse, rubbish or debris, including, without limiting the generality of the foregoing, lumber, bricks, plaster, wire, lath, paper, cardboard, pipe, tires, ashes, refrigerators, motor vehicles or parts of any of the foregoing.
6. No work may be commenced until all appeal periods have elapsed from the order of the Conservation Commission or from a final order by the Department of Environmental Quality Engineering.
7. No work shall be undertaken until the final order, with respect to the proposed project, has been recorded in the Registry of Deeds for the district in which the land is located within the chain of title of the affected property. The Document number indicating such recording shall be submitted on the form at the end of this order to the issuer of this order prior to commencement of work.
8. A sign shall be displayed at the site not less than two square feet or more than three square feet bearing the words, "Massachusetts Department of Environmental Quality Engineering. Number 69-50".
9. Where the Department of Environmental Quality Engineering is requested to make a determination and to issue a superseding order, the Conservation Commission shall be a party to all agency proceedings and hearings before the Department.
10. Upon completion of the work described herein, the applicant shall forthwith request, in writing, that a Certificate of Compliance be issued stating that the work has been satisfactorily completed.
11. The work shall conform to the following described plans and additional conditions:
12. Preliminary Layout Fieldwood Estates Section No. 21 belonging to C. A. Lindberg Inc. by Waterman Eng. Co. March, 1979 Revised November, 1979 Sheet 1 of 2. Said plan being on file with the Seekonk Planning Board.
13. No additional buildings except those shown on the above mentioned plan shall be erected on lot nos 395; 396, 397, 398, and 399 without prior approval from the Seekonk Conservation Commission.
14. All slopes shall be treated with 6 inches of loam and seeded to the satisfaction of the Seekonk Conservation Commission.
15. Prior to the issuance of a certificate of compliance by the commission, the owner, at his own expense, shall employ the services of a registered land surveyor in the Commonwealth of Massachusetts to perform an as-built survey of the completed improvements to insure compliance with the approved plans.
16. All fill areas shall be stripped of loam, topsoil, unsuitable material, etc. prior to placing fill.
17. All fill areas in proposed town roadways shall be inspected by the highway superintendent of the Town of Seekonk prior to and during filling operations.
18. The contractor shall furnish, install and maintain necessary hay check dams or barriers to insure against siltation of the adjoining wetlands during filling operations.
