ADMINISTRATOR KELLOGG EXPLAINED APPOINTMENT TERM OF SERVICE: Appointment terms were done in the following manner: the 1st 2 people appointed to the Commission would serve a 3 year appointment; the 2nd 2 people appointed would serve 2 years; and the 3rd 2 people would serve a 1 year appointment. HOW TO ENCOURAGE ALL SHEFFIELD RESIDENTS TO DISPLAY 911 HOUSE NUMBERS WAS DISCUSSED:

DISCUSSION ENSUED REGARDING PUTTING A DISABILITIES QUESTIONAIRE WITHIN THE 2010 CENSUS MAILING: A discussion ensued about how best to inform the Sheffield residents about the newly formed Commission on Disabilities and how best we could serve our community, what disabilities we needed to address, what issues and concerns. It was decided that putting together a small insert in the census mailing going out in January might be the best way to get voluntary feedback. There are approximately 1500 to 1600 households in Sheffield that could be reached in that manner. There would be no cost to the commission to place this information gathering sheet within the Census mailing. Having a Disability Informational Questionnaire inserted into the Sheffield Census 2010 mail out was made into a motion, seconded, and so approved unanimously.

ADMINISTRATOR KELLOGG SHARED WITH THE COMMISSION MEMBERS THAT JACK POLLITT HAD SPOKEN WITH HIM AND THAT JACK FELT HE WOULD BE UNABLE TO SERVE ON THE COMMISSION ON DISABILITIES: Administrator Kellogg shared his regrets and we as well, that Jack Pollitt felt that he was going to have to resign from the Commission on Disabilities.
