PARSONS AND PERRY PRESENTED PHOTOS AND ACCOMPANYING SHEFFIELD BUSINESS AREA RTE. 7 CORRIDOR MAP REGARDING THEIR FINDINGS ON THE 5 AREAS IN NEED OF CURB CUTS, SIDEWALKS, AND

ACCESSIBILITY: The discussion zeroed in on 5 locations that were NOT disability friendly/or useable:

- 1.) Miller Ave
- 2.) Antique Shop
- 3.) Wheeler and Taylor to town center
- 4.) Library
- 5.) Berkshire School Road cross-over

An excellent presentation was made by Parson's and Perry on behalf of the Commission to Administrator Kellogg which included the large 8 x 10 mounted photos of the areas under discussion. The Commission asked Administrator Kellogg what our next step might be in moving this issue and concern forward.

Kellogg suggested that the next step might be to work up a presentation to give to the Sheffield Town Board of Selectmen. When we were ready to make our presentation that we then needed to ask them to put us on their agenda.

DISCUSSION FOLLOWED ON HOW WE MIGHT GO THE NEXT STEP TO MAKE A MEANINGFUL PRESENTATION TO THE BOARD OF SELECTMEN:

It was moved, seconded, and unanimously approved that we continue to move this huge undertaking along and that we should set a date with the Sheffield Board of Selectmen to demonstrate why this issue is so in need of being addressed.

 directional signs if one is dropping off or picking
 up a disabled person in front of the Town Hall
- 2.) Help button for front door assistance needed

- 3.) Power assist button for Sheffield Town Hall front door
- 4.) Exit sign for the 2nd floor back stairs

 Administrator Kellogg says the Town Hall Exit

 Signs meet code and they only need one for the upstairs main use stairwell
- 5.) Small bench or solid seat/chair for entryway waiting
- 6.) Voting moved back to the Sheffield American Legion
- 7.) Evacuation chair for the Town Hall
- 8.) Administrator Kellogg said he would be interested in seeing information regarding evacuation chairs. Grunfeld said she would E-Mail various pertinent web site information to him and us as well.
- 9.) Do we have a liaison person for this committee?

 Administrator Kellogg told us that

 Assistant Town Administrator Rhonda LaBombard is our liaison person
- 10.) Do we need to write, in a formal document, our suggestions, concerns, to get feedback to the concerns we make known?
- 11.) No, what we need to do is pass them along to Assistant Town Administrator, Rhonda LaBombard and she will direct them down the line further
- 12.) This Commission still needs to be added to the Town of Sheffield's Web site along with our Commission approved Logo.

TOWN ADMINISTRATOR JOE KELLOGG WAS ASKED IF HE WOULD SHARE THE LATEST SENIOR CENTER PLANS WITH US: His response was sometime down the road he would get the plans to us.
