APPROVAL OF MINUTES: <u>Minutes of the Commission on Disabilities for March 18,</u> 2011 were moved to be approved by Grunfeld, seconded by Perry, and unanimously <u>approved as written.</u>

REPORT ON C.O.D. NEW MEMBERS' RECRUITMENT PROGRESS:

CHANGING C.O.D. MEETING DAY AND TIMES: the when and where to hold future C.O.D. meetings was discussed. After considerable discussion, <u>Grunfeld moved, and</u> <u>Perry seconded that the Sheffield C.O.D. would meet on the 3rd Friday of each month at 3:30 PM – 5:00 PM.
