DISCUSSION AND EVALUATION OF THE C.O.D. SPEAKER SERIES CONTINUED:

much discussion followed regarding the C.O.D. Speaker Series. Martin suggested the C.O.D. Speaker Series be combined with the Senior Center's 3rd Thursday of the month luncheon. Combining the programs could be of mutual benefit to both organizations. Perry moved that we cut back the Speaker Series during the winter to every 3rd month with our last Speaker Series of this year to be our October one, since it had already been advertised, and then the next one would be scheduled as a combined C.O.D. / Senior Center Speaker for the 3rd Thursday of January Senior Center Luncheon if John-Arthur was receptive to our combining our Speaker Series with his 3rd Thursday of the month luncheons. Wells seconded Perry's motion and after more discussion it was unanimously so approved. Martin was asked to discuss the proposal with John-Arthur Miller.

C.O.D. CURRENT MEETING DATE AND TIME REVISITED: discussion followed regarding whether the day and the meeting times of the C.O.D. was hindering Sheffield residents from joining the Commission or attending the Speaker Series.

PUBLIC MEETING ACCOMMODATIONS: discussion followed about other ways to let citizens of Sheffield know that assistive devices for use at Town Meetings and other Town Events could be made available to them by notifying the Town ADA Coordinator or the Sheffield C.O.D. with a two week advance notice window. *Perry moved that Grunfeld share with Assistant Town Administrator LaBombard that the Sheffield C.O.D. would like the Town Moderator and other officials at Sheffield Town gatherings to announce at each gathering that assistive devices could be available for future events. Wells seconded <i>Perry's motion and it was unanimously so approved.*
