- 1.) C.O.D. MEETING TO BE CONTINUED: Grunfeld moved to discuss only 3 items at this meeting. That the remaining proposed September 28, 2012 C.O.D. agenda items would be continued at a meeting scheduled for October 5, 2012 @ 3:30 PM in the Sheffield Senior Center. The Grunfeld motion was seconded by Mullen and unanimously approved.
- 2.) SHEFFIELD C.O.D. THANK YOU NOTES: Discussion followed regarding whether to send Thank you notes to those who were instrumental in making the Sheffield Celebration an accessible and fun event for all. <u>Grunfeld moved that we send out 6 Thank You notes, Wells seconded her motion, and it was unanimously so approved.</u>

- 3.) **2 SHEFFIELD C.O.D. SPEAKER SERIES' FLYERS:** 2 different flyer design submissions were discussed at much length with no consensus. A sub committee of Grunfeld and Mullen will design the C.O.D. October 18 Speaker Series' Flyer and they will also be the distributors of the 30 35 flyers.
- 4.) **OPEN MEETING LAW WHAT DOES IT MEAN AT A PRACTICAL LEVEL?:**Much discussion ensued regarding possible understandings/interpretation of the Open Meeting Law. In other words, what does it mean to the Sheffield C.O.D. and how does it effect day to day Commission needs? *It was moved by Mullen that the Sheffield C.O.D. ask LaBombard, Town Administrator, to come to one of the C.O.D. meetings to explain the Open Meeting Law and how to apply it in practice, to the day-to-day operation of a small town commission. Mullens' motion was seconded by Wells, and was unanimously approved.*
- 5.) LUNCHEON DONATION TO THE FRIENDS OF THE SHEFFIELD SENIOR CENTER: The C.O.D. has invited the 5 persons who will be part of the October 18, Speaker Presentation to join the Senior Center Luncheon. Wells moved that since the Senior Center Luncheon was a money maker for the Friends of the Sheffield Senior Center, that the C.O.D. should take up a collection from its members, a total of \$25, to offset those 5 meals. Mullen seconded Wells' motion, and it was unanimously approved as moved.
- 6.) SETTING A DATE FOR SPRING 2013 COLLABORATIVE EVENT:
 Discussion followed regarding the dates and times that the school suggested for the spring 2013 event at Mt. Everett High School February 13 or February 27, 2013 from 3 to 5 PM. Wells moved that this item be tabled until our next meeting when ALL C.O.D. members might be able to share their thoughts on the suggested dates and especially regarding the suggested time of 3 5 PM. Mullen seconded Wells' motion, and it was unanimously approved as moved.
