**C.O.D. ASSISTIVE TECHNOLOGY ACCOMMODATIONS:** It was suggested that Grunfeld ask LaBombard if the Town would post a news flash notice that would let Sheffield residents know that they could asking for assistive technology assistance for Town events with a two week ahead of time request.

**ASSISTIVE TECHNOLOGY FLYERS:** Wells reported that the newly re- designed Assistive Technology Flyers have been approved by LaBombard.

**NEW C.O.D.
